#### 2008 Annual Report Section I- EXECUTIVE SUMMARY

#### **Description of the Department of Transportation**

The South Carolina Department of Transportation (SCDOT) is charged with the responsibility of systematic planning, design, construction, maintenance, and operation of the state highway system and coordinating mass transit services. SCDOT operates and maintains 41,500 miles of roads and bridges, which ranks as the fourth largest state owned highway system in the nation according to the Federal Highway Administration. The agency's emphasis in 2008, and into the foreseeable future, is on system maintenance and preservation, safety, and environmental stewardship.

#### Mission and Values:

SCDOT coordinates state and federal programs relating to highways and public transportation among all departments, agencies, and government entities throughout South Carolina along with other duties and matters as may be delegated by law. The goal of the Department is to provide adequate, safe, and efficient transportation services for the movement of people and goods. With the recent increase in local-option sales taxes for transportation, the creation of the South Carolina Transportation Infrastructure Bank, and the continued development of regional and metropolitan planning organizations, the importance of intergovernmental cooperation has grown. The Department has committed itself to collaboration and consultation in the exercise of its responsibilities. SCDOT is now a cabinet agency taking much of its operational direction from the executive branch of state government, but it must continue to follow numerous federal laws and regulations associated with the Federal-Aid Highway and Federal Transit programs. SCDOT has embraced a number of recent trends in federal transportation policy, emphasizing the importance of:

- 1. Making highway safety the agency's number one priority
- 2. Proactively consulting with affected individuals and stakeholders
- 3. Addressing congestion management in innovative ways
- 4. Using intelligent transportation systems (ITS)
- 5. Making transportation plans consistent with local planned growth and development pans
- 6. Creating bicycle and pedestrian alternatives
- 7. Making projects and programs sensitive to the human and natural environment
- 8. Considering homeland security as a distinct planning factor
- 9. Forming Public-Private partnerships to meet the transportation needs of the state
- 10. Working with the Department of Revenue, the Budget and Control Board, the Comptroller General and other agencies to improve management of finances

#### **Key Strategic Goals for Present and Future Years**

- Increase SAFETY both on South Carolina's highway system and within SCDOT by reducing lost workdays, traffic fatalities, and traffic injuries.
- Ensure South Carolina's future by making transportation MOBILITY options more accessible, convenient, efficient, and easily integrated with existing infrastructures that allows the timely delivery of goods and services.
- Maintain a quality WORKFORCE of existing and future employees.
- Conserve RESOURCES throughout the agency.
- Continue a proactive approach in SYSTEM PRESERVATION by maintaining our existing highways, through preventive maintenance, minor rehabilitation, and routine maintenance.
- Advance SCDOT's CUSTOMER SERVICE through the ability to manage for results and promote transportation solutions that enhance communities and protect the natural and built environment.

#### **Opportunities and Barriers**

Much effort was made in 2008 to accomplish full implementation of Act 114 of 2007. This included the promulgation of regulations covering: the approval and reporting of public requests for services made to the Commission; the prioritization of projects; and the establishment of quantifiable and objective standards for the approval of routine maintenance and operation requests made to the Secretary of Transportation. The Office

of Chief Internal Auditor was created and extensive reviews were begun to ensure accountability with state and federal regulations. Several laws were enacted in 2008, creating new opportunities and challenges for the agency. The load limit was increased for certain types of trucks, resulting in the need to re-examine hundreds of bridges across the state for posted weight limits. The Legislature transferred responsibility for the South Island ferry in Georgetown County to the Department of Natural Resources, thereby relieving SCDOT of future liability. Funding for reopening and maintenance of seven Commercial Motor Vehicle Rest Areas was cut in the State Appropriations Act.

SCDOT has experienced a ten-year increase of more than 10% in the composite Construction Cost Index and an 18% increase in Vehicles Miles Traveled. During that same period, state-source revenues for SCDOT have grown only 2.8%. In the spring of 2008, state-source revenues actually began decreasing for the first time in more than 30 years as a result of increased fuel cost and the slower sales of motor fuel. As a result, the agency put a "delay in hiring" policy in place requiring that vacancies be held open for six months before being advertised. Other costs-savings measures include reducing travel expenses, deferring equipment replacement, and the downsizing of the administrative vehicle fleet. According to a report by the Reason Foundation, The 17th Annual Report on the State Highway Systems, South Carolina is ranked second in the nation for overall cost effectiveness.

Highway maintenance remains the Department's greatest challenge as the state's 41,500 miles of roads and 8,329 bridges continue to age. Many of the roads and bridges do not qualify for Federal funding for maintenance. Overall highway funding in South Carolina is expected to increase over the next five years, but this will require additional state matching dollars, thus putting a greater strain on the state's ability to provide highway maintenance dollars.

Today's high fuel prices encourage people to consider alternative transportation such as rail and bus. This presents the Department with an opportunity to enhance transit services and advance rail planning. The greatest barrier to progress in the field of public transportation in SC remains funding: less than 50 cents of every transit dollar sent to Washington is returned to SC for use in Mass Transit.

#### **Funding and Planning**

Each year, the state appropriations process focuses almost exclusively on general fund agencies with no built-in review of transportation needs that are funded by the State Highway Fund. State Highway Fund revenues are not included in the annual Board of Economic Advisors (BEA) briefing to the House Ways and Means Committee and the Senate Finance Committee. This has contributed toward the long-term disparity in growth between the General Fund and the State Highway Fund. To help inform the General Assembly of funding and planning needs, the Secretary of Transportation has established the practice of delivering an annual "State of SCDOT" presentation to the Senate and House Committees responsible for highway policy and funding. It is hoped that this opportunity to inform legislators will result in efforts to adjust funding and improve public policy. SCDOT is guided by a 20-year needs assessment and plan from the state's

ten Councils of Government, ten Metropolitan Planning Organizations, and data derived from the continuous inspections of all roads and bridges. A 20 year Statewide Multi-Modal Plan was completed in 2008.

#### **Completion of Projects**

Following is a list of the 10 largest construction projects completed in 2008:

- 1. 6 miles of widening from 2 to 5 lanes along SC 6 from US 378 to S-107 (Old Bush River Road) including three bridges totaling 740 feet (a 90' bridge over 14 Mile Creek on Old Cherokee Rd., a 90' bridge over 14 Mile Creek on SC 6, and a 560' bridge over the Lake Murray Dam Spillway on SC 6). A 3410 foot long MSE wall was constructed along the southbound lanes on the dam allowing enough width to construct a multi-use path along the top of Lake Murray Dam. C. Ray Miles Construction Co., Inc. performed this work for \$31,133,384.67. (SCDOT File 32.148B)
- 2. 5.8 miles of widening from 2 to 5 lanes along SC 72 from 0.6 miles east of Richard B. Russell Lake Bridge to 0.55 miles east of SC 162. Approximately 2 miles was on new location. Satterfield Construction Co., Inc. performed this work for \$26,007,171.91. (SCDOT File 1.110B)
- 3. This project consisted of 4.8 miles of widening SC 295 in Spartanburg County from 2 to 5 lanes, to include a 10' multi-use path. Also included in this project were two bridge replacements, a 75' span over CSX Railroad, and a 140' span over Fairforest Creek. Sloan Construction Co., Inc. performed this work for \$17,066,353.64. (SCDOT File 42.137B)
- 4. 7 miles of widening from 2 to 5 lanes along US 378 from west of road S-18 to east of US 378 Business. This work was performed in Clarendon, Florence and Williamsburg Counties by Key Constructors, Inc. for \$16,287,873.73. (SCDOT File 14.119B)
- 5. This 0.5 mile project consisted of replacing the US 17 bridge over the Comabahee River at the Beaufort/Colleton County line. The new structure carries 5 lanes of traffic, and is 840' long. This work was performed by United Contractor's, Inc. at a cost of \$14,576,098.24. (SCDOT File 715.101B)
- 6. This 1.7 mile project included the replacement of 4 overflow bridges on new alignment on SC 377 in Williamsburg County. The bridge lengths are 360 feet, 460 feet, 440 feet, and 420 feet. This project also includes intersection upgrades at US 521/SC 377. This work was performed by United Contractors at a cost of \$14,298,868. (SCDOT File 45.131BR1)
- 7. Rest Area construction on I-20 in Kershaw County. Includes improvements on entrance and exit ramps, new rest area buildings, new vending buildings, water

- and sewer, picnic tables, benches, and shelters. This work was performed by U. S. Group, Inc. for \$12,068,015.30. (SCDOT File 28.119B)
- 8. 3.5 miles of new roadway, side roads and ramps for the Fantasy Harbor Interchange and future bridge over the Intercoastal Waterway from Harrelson Boulevard to George Bishop Parkway. This work was performed by L. Dean Weaver Construction Company at a cost of \$10,998,429. (SCDOT File 26.159BR1)
- 9. This project consisted of widening 4.0 miles of US 21 in Beaufort County from 2 to 3 lanes, to include the addition of 5' paved shoulders. This widening will allow for two lanes outbound and one lane inbound during hurricane evacuations. This work was performed by U.S. Group for \$10,798,866.45 (SCDOT File 7.564R1)
- 10. 3.3 miles of widening from 2 to 4 lanes on SC 68 in Hampton County from I-95 west toward Hampton. This work was performed by Rea Contracting at a cost of \$6,577,135. (SCDOT File 25.105B)

#### Ten-Year Highway Plan

In June of 2007, Act 114 was signed into law, requiring the SCDOT Commission to ensure that transportation projects originate from an established priority list to the extent permitted by federal laws, taking into consideration the following criteria: financial viability, public safety, potential for economic development, traffic volume and congestion, truck traffic, pavement quality, environmental impacts, alternative transportation solutions, and consistency with local comprehensive plans.

SCDOT, in consultation with its partners, established ranking procedures for projects in the areas of bridge needs, intersections, primary and secondary system road widenings, new location corridors, interstate widenings, interchange and maintenance, mass transit, Congestion Mitigation and Air Quality (CMAQ) projects, traffic control devices, and other state funded programs.

#### Reduce the Number of Miles on the State System

The SCDOT Commission placed a cap on the size of the ever growing secondary system in 1994 in an effort to reduce the burden on the Department's under-funded maintenance program. Reducing the size of the system could best be accomplished by returning all or a portion of the non-federal aid secondary roads to counties or local municipalities. Many of these roads are located in residential areas and are therefore not significant to the movement of goods and services on a statewide basis. Doing this would reduce the size of the state highway system to approximately 20,594 centerline miles, leaving South Carolina with the ninth largest state maintained system in the nation. Reducing the size of the state system would enable SCDOT to provide a higher level of service than is presently possible, given the limited funds available for maintenance.

#### Pavement Improvement and Preservation Program

All roads on the state highway system are evaluated on a regular basis to determine the structural condition of the pavement. Interstate routes are evaluated annually, with Primary and Secondary roads evaluated every three years. This data, along with the other objective and quantifiable factors approved by the SCDOT Commission, is used to rank roads for one of the following programs:

- Reconstruction the replacement of the entire existing pavement structure with an equivalent or increased pavement structure. Reconstruction is required when a pavement has failed or reached its minimum acceptable operating condition.
- Rehabilitation consists of structural enhancements that extend the service life of an existing pavement and/or improve its load carrying capacity. Examples of rehabilitation would include asphalt overlays greater than one and a half inches, or lifts of binder course followed by an asphalt overlay.
- Preventive maintenance a planned strategy of cost-effective treatments to an existing pavement that preserves and retards future deterioration, and maintains or

improves the functional condition of the system. Examples of preventive maintenance include crack sealing, bituminous resurfacing, slurry or microsurfacing, thin lift asphalt overlays, and diamond grinding.

Funding for pavement improvement and preservation has been traditionally inadequate to maintain the highway system at an acceptable level of service. The Pavement Improvement and Preservation Program should be initially funded at a level that will maintain the present condition of the system, and then be incrementally increased to raise the system condition to the desired level of service. Present funding is not adequate to maintain the system in its current condition.

#### **Deficient Bridges**

One of the goals of the Department's strategic plan has been to reverse the upward trend in deficient bridge deck area. The present level of federal funding for bridge replacement should provide for a sufficient number of bridge replacement projects to begin to reverse the upward trend in deficient bridge deck area downward. Bridges are prioritized for replacement using objective and quantifiable factors approved by the SCDOT Commission.

#### Increase Routine and Preventive Maintenance

Inadequate funding for the maintenance of South Carolina's highway system has required the Department to react to the needs of the system, rather than to anticipate the system's needs. Therefore, some routine and preventive maintenance activities are being deferred due to a lack of funding, thus leading to the further deterioration of the system. An increase in maintenance funding will allow the Department to move away from a reactive mode and allow a more proactive approach that includes the scheduled routine and preventive maintenance activities necessary to improve the condition of the highway system.

#### Define a Long-Range Vision for Mass Transit

- Identify needs for intercity transit and passenger rail service
- Implement regional human health service coordination plans to improve efficiencies of resources and service
- Maintain an inventory of all Railroad Right-of-Way
- Coordinate on all railroad right-of-way abandonment actions to ensure that right-of-way is preserved for future public use

#### Traffic Engineering

Intelligent Transportation Systems (ITS)

The solutions to the nation's transportation needs include many technological innovations. Federal transportation programs are steadily moving toward the expanded use of such technology to avoid building more highways. This is extremely important for the future of our nation and our state.

The South Carolina Department of Transportation is implementing ITS elements in its statewide traffic management program. ITS elements allow incidents to be detected more quickly, emergency services dispatched sooner, motorist information to be posted on Changeable Message Signs and traffic flow restored. This translates into less secondary collisions from traffic congestion and faster emergency service in rural areas. ITS elements include the use of a motorist's assistance program, video cameras, changeable message signs, speed detection systems and highway advisory radios. Real time information is gathered and used to inform motorists of actual traffic conditions. With assistance from previous federal funding, the SCDOT ITS program is presently deployed at strategic locations on high volume interstates and in critical areas along the coast. There is a need to expand the system further and to include rural interstate and other primary roadways for traffic management and security. The system has hundreds of applications beyond traffic management. It can also be used to support Emergency Medical Services, Amber Alerts, military convoys, travel advisories issued by the news media and many other applications.

Hurricane activity has brought increased attention to the need for additional ITS coverage on critical evacuation routes. The use of cameras and automatic vehicular speed and count stations are valuable in monitoring progress during evacuations. Expansion of the ITS elements on these routes would provide essential traffic flow information to those who must make critical decisions involving evacuations.

The following are proposed projects in the Ten Year Plan for ITS expansion and a regional traffic management center for the operation of ITS systems that are in the design stage.

#### • Charleston SCDOT Traffic Management Center

A permanent Traffic Management Center for the Charleston area to replace the existing center located in a temporary manufactured trailer is under design. This new center will be a new building adjacent to the existing SCDOT District office. It will be constructed to withstand hurricane winds to assure continuing operation of the SCDOT district operations and traffic monitoring following a hurricane.

#### • 511 Traveler Information System

In July 2000, the Federal Communications Commission officially assigned 511 as the abbreviated dialing code for travelers to access real-time traffic information collected in each state. Currently, 34 states are participating in the program, and the rest are expected to roll out the service by 2010. SCDOT has been planning a 511 system for South Carolina. The first effort is this project included the request to the Public Service Commission to designate SCDOT as the agency for 511. This request was approved in February, 2008. The next step in the process was the awarding of an integrated software package for the ITS system that will support the 511 system. This software package was purchased and the integration and installation is underway.

The system for South Carolina is envisioned to incorporate the traffic information gathered from the Department's ITS systems as well as maintenance and construction activities into one central location that motorists can access by dialing 511 on their phones or may be obtained via the internet for pre-trip planning.

### SFY2007-2008Annual Report Input Division of Mass Transit

#### Introduction

By statute, the South Carolina Department of Transportation (SCDOT) Division of Mass Transit must develop and coordinate a general mass transit program and policy for the State of South Carolina in order to encourage the efficient development, implementation, operation, evaluation, and monitoring of mass transit systems, both public and private. The information contained within this report provides a summary of mass transit programs for SFY2007-2008.

The Division of Mass Transit is the primary agency responsible for the administration of federal and state funds for the provision of public transportation services in the State. In this capacity, the Division of Mass Transit, under the authority of the SCDOT Commission, assists in the development of statewide and regional transit plans, develops and implements transit programs to meet statewide objectives and local needs, and provides ongoing oversight and monitoring of local transit providers and grant programs. In addition, it provides funding for technical assistance to local transportation providers. In this role, the Division of Mass Transit works closely with local transit providers to develop and fund demonstration projects and special services to enhance transit services in rural areas of the State.

#### **Profile of Public Transit Providers**

Public transit services are provided by a variety of public providers across the State, including urban transit systems, cities, Regional Transit Authorities (RTAs), Councils on Aging, and counties. Under the umbrella of public transit services, providers deliver transportation services that support general public needs, employment, tourism, and economic development across the state. The types of services offered by local transit providers depend on size and population density of the area served, as well as geography. Some agencies provide fixed-route services that operate on a regularly scheduled interval, while others offer demand-response service that provides door-to-door or door-through-door transportation. Figure 1 provides a map of public transit providers across the State operating in FY2007-2008.



#### **Federal and State Funding Programs**

The primary goal of the Division of Mass Transit is to facilitate, develop and implement mobility options within South Carolina by partnering with local and regional stakeholders. The Federal Transit Administration (FTA) apportions transit funding to the state for Non-Urbanized Area (Rural) transportation, Elderly Individuals and Individuals with Disabilities Program, Job Access Reverse Commute, New Freedom and funding for statewide planning and training assistance. Each Large Urbanized and Small Urbanized area within the state is also apportioned formula funds for transit through FTA and they apply directly to FTA for funding.

State funds are utilized to match federal funds, thereby maximizing the state's use of its federal fund allocations. The Division of Mass Transit also provides state funding (on a discretionary basis) for special projects to transit providers. To assist in meeting the public transit needs within the state, approximately \$45.37 Million in combined federal and state funds was apportioned to the state for transit program and planning activities in FY2007-2008 (Figure 2).



#### **SmartRide**

In FY 2007-2008 the Camden-Lugoff route as well as the Newberry route noted significant increase in ridership (as shown below) beginning in the months of May and June at the height of the spike in gasoline prices. The increase in ridership is evidence of consumer-demand for

economy in commuting habits, as it was more economically feasible for patrons to access commuter routes than to bear the expense of single-occupant commuting. The Camden-Lugoff route posted a total ridership of 13,167, and the Newberry route posted 11,947 for a total of 25,114 passenger boardings as shown in Figure 5.



### **Rail Development**

SCDOT completed the South Carolina Statewide Comprehensive Multimodal Transportation Plan that included as one of its key elements a Rail Right-of-Way Inventory. This study identified South Carolina's active railways, abandoned railways and short-line railways. This information will be used to implement a rail corridor preservation and revitalization plan for preserving railroad right-of-way for future use as required under Section 57-3-40 (B) and (D) of the South Carolina Code of Laws. SCDOT also received a final report on a separate study evaluating high speed options in the Macon-Atlanta-Greenville-Charlotte Rail Corridor. Georgia, South Carolina, North Carolina and Virginia are working together to explore options to implement high speed rail in the southeast.

SCDOT is involved with several studies currently underway in the Columbia, Charleston and Florence areas. The Centrals Midlands COG received a Federal Transit Administration grant to study alternative transportation solutions, including commuter Rail, in the Columbia area. The BCD COG received a Federal Transit Administration grant to study alternative transportation solutions, including commuter rail, in the Charleston area.

SCDOT is conducting an in-house feasibility study in the Florence-Myrtle Beach-Charleston areas to identify a corridor for the purpose of constructing and providing passenger rail service on existing rail lines and/or existing railroad right-of-way in the eastern part of the state.

Utilizing these studies should assist in identifying rail service needs in South Carolina. The vision is to have a seamless transportation system that integrates commuter rail, light rail, and

bus transportation to provide rapid modes of transportation. These systems working in unison will promote the growth of industry and tourism, making the State of South Carolina a more appealing place to live, work and visit.

#### **Coordination of Transportation in South Carolina**

Governor Mark Sanford has signed a bill into law that created a study committee charged with reviewing all mass transit systems and human services transportation systems in South Carolina. The bill was signed by the Governor on May 14, 2008 (Act 403).

The Mass Transit and Human Services Transportation Programs Study Committee is expected to report on the status of these programs including their current level of use, funding, potential availability of additional funds and efficiencies of the systems. The Committee is reviewing the twenty-four (24) general public transit providers and approximately 120 human service transportation systems that serve disabled and elderly South Carolinians.

#### The Committee's membership includes:

- One member each appointed by the Governor, the President Pro Tempore of the Senate and the Speaker of the House. Each of the three members must represent the transportation community.
- The Chairs of the Senate Transportation Committee and the House Public Works Committee or their designees.
- The Secretary of Transportation, president of the Transportation Association of South Carolina, executive director of the State Budget & Control Board, or their designees.
- One member to represent the Council of Governments.
- The state directors of the Department of Social Services, the Department of Health and Human Services, the Department of Disabilities and Special Needs, the Department of Mental Health and the Vocational Rehabilitation Department or their designees.
- The Secretary of Commerce and the director of the Lieutenant Governor's Office on Aging or their designees.

The Committee's final report must be filed before March 13, 2010, but is expected to be completed in early 2009.

## **Virtual Transportation Enterprise (VTE) Program**

The VTE project is a federally-funded intelligent transportation system (ITS) that began in 1999. The project is geared towards utilizing technology to leverage transit resources in the State. The project has four main focus areas: communications, electronic reporting/invoicing, automated scheduling and dispatching, and fleet maintenance management. The program is designed to provide increased operating efficiencies to both transit providers and the Division of Mass Transit.

The virtual enterprise concept takes advantage of the economies of scale that result when a group of independent, self-sufficient organizations with common purposes share information technology (IT) resources rather than duplicating high-cost technological investments at numerous locations. A virtual enterprise works best when the individual organizations have a common type of business, are geographically dispersed with limited competition with each other, have mutual respect for each other, and are motivated to reduce IT infrastructure costs through standardization and increase revenue through integrated services among members. The enterprise is *virtual* because the organizations communicate and share information with each other and conduct their business from remote sites using Web-based communications with standardized software and hardware infrastructure resources located in a central location.

One vision realized through the VTE program includes RouteMatch Software implementation at the following locations:

- > Senior Services of Chester
- ➤ McCormick County Senior Center
- ➤ Newberry County Council on Aging
- ➤ Williamsburg Transit System
- ➤ Fairfield County Transit System
- ➤ Waccamaw Regional Transportation Authority (Coast RTA)
- > Santee Wateree RTA
- ➤ Lower Savannah RTMA
- > Spartanburg Regional Health Care System
- ➤ Generations Unlimited

Other accomplishments include the creation of the VTE website where SCDOT hosts a variety of forms for invoicing and tracking for SCDOT subrecipients (Figure 6). The creation of these forms allows for online reporting and "paper-less" project management.




## **Vehicle Acquisition Program**

In FY 2002, the Division of Mass Transit initiated the Vehicle Acquisition Program (VAP). This program was initially designed to maximize available earmark funds to replace South Carolina's aging transit fleet within three to five years, whereas conventional replacement methods would take ten to fifteen years. The expected outcomes are to purchase new vehicles for each transit agency, assist in improving customer satisfaction, ensure vehicle reliability, and reduce maintenance costs. Through assessments, a total of 508 vehicles have been identified to be replaced under this program.




Figure 7 Figure 8

Figure 7 indicates the types of vehicles purchased through the VAP. Cutaways are requested more frequently than any other vehicle. Cutaways are smaller 10- to 17-passenger vehicles, which are more fuel efficient and are Americans with Disabilities Act of 1990 (ADA) compliant. Figure 8 represents the vehicles that have been replaced through the VAP to date. In FY 2007-2008, a total of 33 vehicles were replaced statewide bringing the total amount of "replaced" vehicles to 379, or 75% of the program goal. The remaining 25% of vehicles to be replaced under the VAP are planned to be replaced over the next two to three fiscal years utilizing available Section 5309 earmark funding. The Vehicle Replacement Program is a very successful and cost effective program.

#### **Key Measures**

The Division of Mass Transit's key measures are total passenger boardings (ridership) and total operational expenses:

- Annual passenger boarding data (Figure 9) provides information that shows how many one-way passenger trips were reported by transit providers (statewide) for the fiscal year;
- Annual operating expenses data (Figure 10) provides information that shows the cost reported by transit providers that is associated with the actual transit service delivery.

On an annual basis, each transit provider submits data for the two key measures to the Division of Mass Transit and Transit Planning Division. The information is then compiled and analyzed to determine statewide trends. The data is critical because it is used to a certain degree to make funding decisions and provides a financial oversight mechanism through statewide trending analysis as well as individual review and assessment.




