Dear Mr. Appleby,

Thank you for talking with me to clarify the request we received from the House Committee on Legislative Oversight and IRF's response.

As we discussed, IRF maintains information by the entity it insures. While IRF is not able to pull the lawsuits in which an individual was personally named, we have prepared a report of all closed claims with lawsuits against all State Agencies. This report lists a very brief cause of claim, date the incident occurred, date the incident was reported to the IRF, date the claim was closed, and amounts paid for losses (settlement or verdict) and expenses (fees for attorneys, experts, court reporters, etc.). The report lists only closed claims and not ones that are open or still in suit.

Also, as we discussed, whenever a lawsuit is received, the IRF examiner assigned reviews and assigns it a cause of claim code. This cause of claim code is assigned at the beginning of the process and there is some flexibility in interpretation. By way of example, if a lawsuit has causes of action for First Amendment Violation; Employment Discrimination; and Wrongful Termination it may receive a cause of claim code for Employee Dispute – Discrimination; or it may receive a cause of claim code for Civil Rights – Misc. Neither is incorrect. The cause of claim code we used to generate report were only those referencing Employee Dispute: ED – Employee Dispute – Discrimination; EF – Employee Dispute – Wrongful Firing; and EM – Employee Dispute Miscellaneous.

The date parameters we used were any closed claim with a date of loss between January 1, 2010, and December 10, 2019.
