Prolonged Incarceration

- 07/27/2016: Sentenced in Charleston County to 7 years suspended upon 883 days incarceration and 5 years' probation for Criminal Solicitation of Minor.
- 07/28/2016: Processed by SCDC for county remote release and released to probation.
- 06/12/2017: Probation is revoked. Sentenced to 5 years' incarceration.
- 06/14/2017: Admitted to SCDC as a probation violator to serve 4 years, 212 days with 62 days jail time.
- 11/21/2019: During the DPPPS special probation revocation audit, it was determined that Inmate was previously a county remote release and due 883 days of Hayes credit. The total time and incarcerative time to serve was 5 years. Upon changing the total time, incarcerative time, and adding 883 days of Hayes credit, release date changed from 10/11/2020 to 11/10/2017.
- 11/21/2019: Inmate released.

Prolonged Incarceration-PPP Audit

- 10/10/17: Sentenced by Cherokee County to 5 years suspended to 1 year with 3 years' probation and 45 days of jail time credit for Financial Transaction Card Fraud.
- 10/18/17: Admitted to SCDC.
- 03/01/18: Released to probation.
- 5/6/2019: Violated probation and sentenced to 2 years with 172 days of jail time credit and, on a General Sessions charge, to 1 year with 40 days jail time credit.
- 05/09/19: Admitted to SCDC.
- 11/21/19: During a maxout audit, it was noted at the bottom of the Form 9 that 15 months had previously been served; however, the original 2017 sentencing sheet indicated 1 year or 12 months with no continuance date written at the top of the Form 9.
- 11/21/19: The Cherokee Clerk of Court was e-mailed at 4:08pm for any additional hearings for this indictment. At 4:16pm the continuance from 10/17/2018 revoking 90 days was e-mailed to the IRO.
- 11/22/19: 90 days added to the Hayes field and release date changed from 01/09/2020 to 10/27/2019.
- 11/22/19: Inmate was released.
