Meeting

- I. Chair West explains that this is the Subcommittee's third meeting with the Department of Mental Health, and that the purpose is to receive further testimony about inpatient services.
- II. Chair West explains that all testimony given to this subcommittee, which is an investigating committee, must be under oath. He reminds those sworn in during prior meetings that they remain under oath. Chair West swears in the following people:
 - a. Phylliss Ross, Advocate (Protection and Advocacy for People with Disabilities)
 - b. Ted Jones, Administrator (DMH Roddey Pavillion)
 - c. Robert Morgan, Administrator (DMH Stone Veterans Home).
- III. Ms. Phylliss Ross provided testimony regarding the combined impacts of changes in the state's Medicaid payment system and the closure of two buildings previously used to serve juveniles from the Department of Juvenile Justice with behavioral and serious mental health issues. Members asked questions regarding the timing of the changes, and the need for beds.
- IV. Interim Director Binkley, Deputy Director Bellamy, and other DMH staff provide testimony about provides testimony about inpatient facilities, highlighting unique aspects of each facility.
- V. Subcommittee members ask, and agency staff respond to questions about the following subjects:
 - a. SVPTP capacity and use of telemedicine;
 - b. Opioid treatment time;
 - c. Cooperation with the Department of Alcohol and Other Drug Abuse Services;
 - d. Efficiency of contracting some services out; and
 - e. Veteran's nursing home capacity.
- VI. There being no further business, the meeting is adjourned.

- Bids in process of being reviewed and awarded




