Public Input on the Commission for the Blind

I. Chairman Ballentine explained that the purpose of the meeting was to provide the Subcommittee with the opportunity to receive testimony about the Commission for the Blind from the public. He said that the Subcommittee would hear testimony from all of those present who had signed up to speak. The name and country or organization of each person is given below, and the italicized notation represents the approximate start time for each person's testimony on the archived video of the meeting. A brief summary of each person's testimony is given below his name.

Paige McGraw, School for the Deaf and Blind 5:09

Dr. McGraw is the agency head of the School for the Deaf and Blind, and shared information about the ways in which the School partners with the Commission in South Carolina. Dr. McGraw answered questions asked by Chairman Ballentine and Representative Taylor.

Scott Falcone, School for the Deaf and Blind 17:21

Mr. Falcone added to Dr. McGraw's testimony about the working relationship between the School for the Deaf and Blind and the Commission for the Blind.

Charles Kierce, Verizon 21:12

Mr. Kierce testified about his positive experiences with fellow employees at Verizon who had a visual impairment and have been benefitted from the services of the Commission for the Blind. Mr. Kierce answered questions asked by Chairman Ballentine, Representative Mia McLeod, and Representative Walton McLeod.

Robert Giles, Student at Commission for the Blind 30:12

Mr. Giles thanked the Commission for the Blind for helping him adjust to new technologies and for helping blind South Carolinians improve their lives and find gainful employment.

Linda Jenkins, Summerville 34:06

Ms. Jenkins testified about her experience of losing her vision due to a degenerative condition, and how the Commission for the Blind helped her find meaning in her life again. Ms. Jenkins answered a question asked by Representative Taylor.

Frank Coppel, National Federation for the Blind in South Carolina *51:54* Mr. Coppel is President of the state chapter of the National Federation for the Blind. Mr. Coppel testified about the Federation's relationship with the Commission for the Blind. Mr. Coppel answered a question asked by Chairman Ballentine.

Gail Wigfall, Diversity and Inclusion Consultant at BlueCross BlueShield of South Carolina *59:06*

Ms. Wigfall testified about her experience as a recruitment consultant dealing with blind employees and the Commission for the Blind. Ms. Wigfall answered a question asked by Representative Mia McLeod.
