# Discussion of the Department of Juvenile Justice

- I. Chairman Tallon opened the floor to questions from Subcommittee members about the updated chart, provided by the agency, related to implementation of the Legislative Audit Council recommendations. Members asked questions, which agency personnel answered.
- II. Chairman Tallon swore in constituent Thomas Williams. Mr. Williams provided testimony to the Subcommittee. Members asked questions, which Mr. Williams answered.
- III. Representatives from DJJ were then given an opportunity to respond to the comments, but said no response was needed.
- IV. Chairman Tallon asked Director Pough to provide a brief summary of the information in DJJ's February 14, 2017 letter to the Subcommittee. Director Pough provided the summary. Members asked questions, which Director Pough and other representatives from the agency answered.
- V. Chairman Tallon directed staff to update the Subcommittee Study Report and provide a copy to all subcommittee members by Friday, February 24, 2017. He stated the deadline for members to include a written statement with the Report, as permitted by Standard Practice 12.4, was 5:00pm on Friday, March 3, 2017. He stated this would be the final Subcommittee meeting to study DJJ, and he would provide notice to the Full Committee that the Subcommittee Study is available for consideration, unless he receives a written request for another meeting from a Subcommittee Member prior to 5:00pm on Friday, March 3, 2017.
