

Law Enforcement and Criminal Justice Subcommittee Bond Bill Requests

Department of Natural Resources

\$1,250,000 – Office Renovations and Reopening

Explanation of the request:

- \$500,000 for Clemson expansion and renovation; \$250,000 for Barnwell renovation and reopen; \$250,000 for Georgetown renovation and reopen; and \$250,000 for York renovation.

\$1,150,000 – Boating Access Facilities

Explanation of the request:

- South Island (Georgetown) rehabilitation of boat ramp/parking for \$225,000
- Murrells Inlet rehabilitation of boat ramp/parking for \$125,000
- Construction of 3 additional boat ramps at Green Pond (Anderson) for \$250,000
- Construction of Canoe/kayak launch for \$250,000 at Cliff Pitts WMA (Laurens)
- Construction of canoe/kayak launch in Ekom Beach (Laurens) at \$300,000

\$5,517,000 – Radio Communication Upgrade

Explanation of the request:

- Provide law enforcement with interoperability radio communications needed for inter-agency incident response for protection of life, property and officer safety

\$2,600,000 – Marine Resources

Explanation of the request:

- Marine Center Boat Slip (Charleston) Renovation of boat slip \$2,000,000
- McKenzie Field Station (Colleton) Rehabilitate seawall, shoreline stabilization \$600,000

\$16,975,000 - Fish Hatcheries

Explanation of the request:

- Waddell Mariculture Center (Beaufort) Replace water distribution system, electrical system and rehabilitate production ponds, replace water control structures \$3,575,000
- Barnwell State Hatchery (Barnwell) Recontour/deepen ponds, replace kettles & water controls \$1,800,000
- Walhalla State Hatchery (Oconee) Reconstruct 6 concrete production raceways \$8,000,000
- Dennis Center State Hatchery (Berkeley) Add 10 new ponds, rehabilitate 10 harvest kettles \$1,900,000
- Cheraw State Hatchery (Chesterfield) Replace water distribution system \$3,500,000

Explanation of the request:

Explanation of request:

- Refurbishment of Masonic Lodge as central warehouse and supply

\$225,000 – IT Area Remodel

Explanation of request:

- Remodel of IT portion of the CJIS/Data Center for IT operations

\$14,000,000 – Replacement Huey Helicopter

Explanation of request:

- Replacement of 1964 Huey Helicopter with a twin engine multi-use helicopter

Explanation of request:

- Replacement of 9 rooftop HVAC units nearing end of life cycle \$490,000

\$20,000,000 – Court Case Management System

Explanation of request:

- CMS enhancements by migrating to a cloud/web base platform

Criminal Justice Academy

\$4,049,745 – Maintenance

Explanation of request:

- HVAC Upgrades in Buildings 10,11 and 12 \$473,452
- Physical Security Upgrades \$108,329
- Re-paving Academy parking lots \$520,905
- Restroom Renovation – renovate 88 restrooms in the oldest dormitories \$1,195,493
- Re-carpet dormitories and administrative areas \$230,799
- Repair warehouse roof \$67,080
- Re-roof building #9 \$53,371
- Renovate/Replace four buildings within the Practical Problems Village \$638,000
- FireArms Training Simulator buildings renovation/replacement \$448,500
- Replace target system of range \$250,000

\$10,225,000 – Deferred Maintenance/General Renovations

Explanation of request:

- \$3,625,000 to get building to fire safety codes; energy conservation; environmental health including indoor air quality and asbestos removal

- \$2,500,000 to refurbish entrance roads in institutions as well as the security inner and outer perimeter roads and staff/visitor parking lots
- \$3,100,000 for Manning Correctional Institution boiler system upgrade
- \$1,000,000 flooring renovation at institutions and admin building

\$1,500,000 – Water/Wastewater Treatment

Explanation of request:

- Repair and replacement of storage systems; well assemblies; lift stations; pumps; motors; blowers; aerators; mechanical bar screens (essential to meet EPA, DHEC and municipal permit requirements)

\$12,700,000 – Food Storage Warehouse Facility

Explanation of request:

- Construction of food service warehouse facility at the Broad River Road complex. The food service complex will include parking, loading docks, industrial size, freezer and cooler storage, dry storage and office/administrative space. This would allow the agency to increase the onsite food production through increased farming operations and allow the agency to preserve excess crops for use during the year.

Explanation of request:
