### **H\*2496 (Rat #0814, Act #0683 of 1988) General Bill, By R.A. Kohn and J.D. Bradley**

A Bill to provide that for a period of two years, the waiting period required by Section 38-73-960 of the 1976 Code may be extended by the Commissioner for an additional period of six months rather than sixty days in the manner permitted by the Section.-amended title
