### **S\*1063 (Rat #0624, Act #0565 of 1980) Joint Resolution, By T.D. Wise, A.R. Carter and W.W. Doar**

A Joint Resolution to create a Committee to Investigate the Existing Oyster and Clam Shellfish Leasing System, existing laws relating to the management and harvesting of oysters and clams and the performance of responsible state agencies in performing their duties relative to the management and harvesting of oysters and clams, to extend existing leases which expire prior to the committee's report and prohibit renewal or reissuance of new leases prior to the committee report.
