### **S\*1157 (Rat #0491, Act #0423 of 1990) General Bill, By Senate Judiciary**

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Chapter 9 to Title 45 so as to provide for the revocation of any license or permit issued by the State or its political subdivisions to an establishment of public accommodations found to practice discrimination on account of race, color, religion, or national origin after a hearing by the South Carolina Human Affairs Commission, to provide exceptions, to provide for judicial review, and to provide for criminal and civil penalties and remedies for violations.-amended title
