A Bill to amend Section 59-103-10, as amended, Code of Laws of South Carolina, 1976, relating to the Commission on Higher Education, so as to revise the manner in which certain members thereof shall be appointed; to amend the 1976 Code by adding Section 59-103-15 so as to define the mission of higher education in South Carolina and of each type of public institution of higher learning.-amended title
