**S\*1213 (Rat #0201, Act #0175 of 2012) General Bill, By Alexander, L. Martin, Scott, Knotts, Peeler, Cromer, Setzler, Leventis, Hayes, Nicholson, Ryberg and Ford**

**Summary:** Medal of Valor Act

AN ACT TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING CHAPTER 67 TO TITLE 2 SO AS TO ENACT THE "SOUTH CAROLINA MEDAL OF VALOR ACT OF 2012", TO RECOGNIZE SOUTH CAROLINIANS, OR INDIVIDUALS WITH CERTAIN TIES TO SOUTH CAROLINA, WHO WERE KILLED IN ACTION WHILE SERVING IN THE ARMED FORCES OF THE UNITED STATES OF AMERICA, TO PROVIDE FOR THE SOUTH CAROLINA MEDAL OF VALOR ROLL, AND TO ESTABLISH THE SOUTH CAROLINA MEDAL OF VALOR AWARD CRITERIA. - ratified title
