**S\*0132 (Rat #0150, Act #0083 of 1983) General Bill, By H.E. McDonald, R.C. Dennis, Leatherman, I.E. Lourie, A.M. Sanders and J.V. Smith**

### ***Similar (H 2184)***

A Bill to amend Title 44, Code of Laws of South Carolina, 1976, relating to health, by adding Chapter 6 so as to create the State Health and Human Services Finance Commission, to provide for its membership and its functions, duties, and responsibilities which shall include administering Title XIX of the Social Security Act (Medicaid), to establish an advisory committee and a transition committee to assist the Commission in the performance of certain of its duties, and to repeal Section 44-5-30, Code of Laws of South Carolina, 1976, relating to the Department of Health and Environmental Control being designated as the single state agency to administer the State's health planning functions.
