A Bill to amend Section 38-51-60, Code of Laws of South Carolina, 1976, relating to the requirement that insurance companies do business through resident licensed agents, so as to require that all policies, except health and accident and life insurance policies, and certificates issued under group insurance policies issued in this State be countersigned by the agent except for amendments or replacement of outstanding policies with revised forms or endorsements.-amended title
