A BILL TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 57-3-785 SO AS TO
PROVIDE THAT THE DEPARTMENT OF TRANSPORTATION SHALL REQUIRE THE PLACEMENT OF CONSTRUCTION
