A Bill to amend the Code of Laws of South Carolina, 1976, by adding Chapter 21 in Title 25, relating to military, civil defense, and veterans' affairs, so as to establish the Veterans' Trust Fund of South Carolina and provide for its powers, duties, and governance; and to amend the 1976 Code by adding Section 12-7-2417 so as to provide a designation on state individual income tax forms enabling a taxpayer to make a contribution to the Veterans' Trust Fund of South Carolina; and to amend the 1976 Code by adding Section 12-51-55 so as to require a minimum bid at a tax sale equal to unpaid taxes, penalties, costs, and current taxes and provide for the application of the amount added for current taxes if the property is not
