### **H\*3453 (Rat #0776, Act #0656 of 1988) General Bill, By Hayes**

A Bill to amend Article 7, Chapter 17, Title 16, Code of Laws of South Carolina, 1976, relating to offenses against public policy by adding Section 16-17-445 so as to provide restrictions upon certain unsolicited consumer telephone calls and the manner in which these calls may be made, to authorize the Department of Consumer Affairs to investigate complaints of violations, and to provide civil and criminal penalties for violation; and to amend the 1976 Code by adding Section 16-17-446 so as to regulate the manner in which automatically dialed announcing device (ADAD) calls may be made.-amended title
