**Summary:** Public Waters Nuisance Abatement Act

AN ACT TO AMEND TITLE 49, CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING CHAPTER 30 SO AS TO ENACT THE "PUBLIC WATERS NUISANCE ABATEMENT ACT" TO ALLOW THE DEPARTMENT OF NATURAL RESOURCES TO REMOVE OR REQUIRE THE REMOVAL OF CERTAIN UNPERMITTED STRUCTURES FROM THE PUBLIC WATERS OF THIS STATE UNDER CERTAIN SPECIFIED CONDITIONS, WITH A CORRESPONDING AUTHORITY OF AN FERC LICENSEE TO DO THE SAME ON A LAKE LICENSED IN CONNECTION WITH A HYDROPOWER FACILITY, CREATES THE PUBLIC WATERS NUISANCE ABATEMENT FUND TO PAY FOR STRUCTURE REMOVAL, PROVIDES FOR PERMITTING AND REGULATION OF EXISTING STRUCTURES FOR ONLY FIVE YEARS, PROVIDES CRIMINAL PENALTIES FOR VIOLATIONS, PROVIDES FOR AUTHORITY OF THE ATTORNEY GENERAL TO DECLARE THESE UNPERMITTED STRUCTURES NUISANCES AND REQUIRE THEIR REMOVAL, AND PROVIDES FOR A CIVIL ACTION BY A PRIVATE CITIZEN; AND TO AMEND SECTION 48-1-85, AS AMENDED, RELATING TO REQUIREMENTS FOR HOUSEBOATS WITH MARINE TOILETS, SO AS TO REDEFINE "HOUSEBOAT". - ratified title
