A Bill to establish an African-American History Monument to be erected on the State House Grounds, to create a Commission to select the design and location of the monument and perform certain other functions, to provide that this Commission shall also study the feasibility of establishing an African-American History Museum and shall make reports and recommendations in this regard to the State House Committee, and to provide for the date this Commission shall be dissolved.-amended title
