### **H\*3567 (Rat #0151, Act #0143 of 1995) General Bill, By Quinn**

A Bill to amend Section 61-1-95, as amended, Code of Laws of South Carolina, 1976, relating to beer, wine, and alcoholic beverage permits and licenses, so as to delete the prohibition on the issue of a permit or license following suspension or revocation to any person within the third degree of kinship to the person whose permit or license was suspended and to prohibit the issuance of a license or permit for one year after the suspension or revocation to a person within the second degree of kinship to the person whose permit or license was suspended or revoked.-amended title
