**S\*0367 (Rat #0174, Act #0124 of 1987) General Bill, By Drummond**

**Similar (H 2397)**

A Bill to reauthorize the State Board of Medical Examiners for six years; amend Section 40-47-25, Code of Laws of South Carolina, 1976, relating to representation of physicians' assistants at meetings of the Board, so as to require the Board to explore the possibility of administering its own examination for purposes of determining a physicians' assistants' competency prior to issuing a temporary or permanent certificate; authorize the Board to impose an examination fee to cover the costs and expenses of administering the examination; and authorize a supervising physician, if employed in a publicly supported or charitable institution providing free or reduced-fee services, to supervise more than one physician's assistant under arrangements approved by the Board.-amended title
