### **H\*3749 (Rat #0617, Act #0499 of 1980) General Bill, By H.H. Keyserling and N.C. Russell**

A Bill to amend Section 40-55-80, Code of Laws of South Carolina, 1976, relating to the application and qualification of licensed psychologists, so as to provide that students graduated prior to December 31, 1978, in a recognized doctoral program shall be governed by the curricular requirements established for licensure by the Board of Examiners in Psychology prior to June 1, 1978.-at
