### **H\*3800 (Rat #0746, Act #0605 of 1990) General Bill, By J.C. Hearn, J.M. Baxley and J.B. Wilder**

A Bill to amend Chapter 34, Title 40, Code of Laws of South Carolina, 1976, relating to the regulation and licensing of nursing home administrators; and to amend the 1976 Code by adding Sections 40-35-131 through 40-35-136, so as to further provide for the regulation and licensing of nursing home administrators and for the regulation and licensing of community residential care facility administrators, including provisions to rename and reconstitute the membership of the State Board of Examiners for Nursing Home Administrators.-amended title
