A BILL TO AMEND SECTION 50-21-133, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO ESTABLISHING A NO WAKE ZONE ADJACENT TO SULLIVAN'S ISLAND, SO AS TO CONFORM ITS PENALTIES TO THOSE PROVIDED IN SECTION 50-21-150 AND TO PROVIDE A SEPARATE NO WAKE ZONE AT THE CHEROKEE PLANTATION ON THE COMBAHEE RIVER IN COLLETON COUNTY.-AMENDED TITLE
