**H\*4354 (Rat #0342, Act #0304 of 1996) General Bill, By Robinson, Allison, Kirsh, Simrill, D. Smith and Walker  
Similar (S 0946, H 4324)**

A Bill to amend Sections 23-28-20 and 23-28-70, both as amended, Code of Laws of South Carolina, 1976, relating to the appointment of reserve police officers and their powers and duties, so as to require an auxiliary and a reserve police officer to be accompanied by a full-time certified South Carolina police officer or a deputy sheriff under certain circumstances, to require a reserve police officer to be in proximate contact with the full-time officer to whom he is assigned, and to require a chief to obtain approval from certain officials to appoint reserve police officers.-amended title
