### **S\*0467 (Rat #0560, Act #0468 of 1990) General Bill, By Drummond**

A Bill to amend Section 50-13-1980, Code of Laws of South Carolina, 1976, relating to fish sanctuaries, so as to provide that they continue as fish sanctuaries unless directed to be closed by the owner of the land where the sanctuary is located or by direction of the legislative delegation of the county in which it is located.
