**H\*4811 (Rat #0608, Act #0453 of 1994) General Bill, By Bailey**

***Similar (S 1101)***

A Bill to amend Section 61-3-1020, as amended, Code of Laws of South Carolina, 1976, relating to the prohibition on the conduct of other business in retail alcoholic liquor stores, so as to authorize the sale of nonalcoholic items instead of nonalcoholic beverages packaged together with alcoholic liquors and to require the packaging at the alcoholic liquor producer's place of business.
