**H\*4833 (Rat #0540, Act #0456 of 1996) General Bill, By Robinson, R.C. Fulmer, Harrell, Haskins, R.J. Herdklotz, C.V. Marchbanks, Rice, Sandifer, Trotter and D.C. Waldrop**

A Bill to amend Section 12-28-795, Code of Laws of South Carolina, 1976, relating to interest due on gasoline tax refunds, so as to correct the reference to the provisions on interest on tax overpayments and underpayments; to amend Section 12-28-2360, relating to refunds of gasoline tax inspection fees, so as to extend the general limitations on the assessment of state taxes to claims for refunds.-amended short title
