A Bill to establish the Motor Vehicle Theft and Motor Vehicle Insurance Fraud Reporting-Immunity Act, to provide for the exchange of information relating to motor vehicle theft or motor vehicle insurance fraud between authorized governmental agencies and insurers, to provide for immunity from civil and criminal liability for the exchanges, to provide for confidentiality, and to provide a penalty.
