### **S\*0981 (Rat #0733, Act #0593 of 1990) General Bill, By M.T. Rose and Wilson**

A Bill to amend Title 44, Code of Laws of South Carolina, 1976, relating to health, by adding Chapter 107 so as to enact the Drug-Free Workplace Act and to amend the 1976 Code by adding Section 41-1-85, so as to provide that the use of tobacco products outside the workplace must not be the basis of a personnel action.-amended title
