Fiscal Impact Summary

This bill will have no expenditure impact on the General Fund, Federal Funds, or Other Funds for the Department of Administration, Senate, or House of Representatives. This bill has no expenditure impact because the study committee members will not receive compensation and are not entitled to receive mileage, per diem, or subsistence.

Explanation of Fiscal Impact

Introduced on February 20, 2018

State Expenditure

This bill is a joint resolution to establish a study committee to review the events of February 8, 1968, referred to as the "Orangeburg Massacre," and to make a report to the Governor and General Assembly concerning the historical, social, and ethical ramifications of those events. The study committee will be composed of three members to be appointed by the Governor, one of whom the Governor must designate as chairman of the study committee, two members to be appointed by the President Pro Tempore of the Senate, and two members to be appointed by the Speaker of the House of Representatives.

The members of the study committee will not receive compensation and are not entitled to receive mileage, per diem, or subsistence. The study committee must submit a report containing its findings and recommendations to the Governor, the President Pro Tempore of the Senate, and the Speaker of the House of Representatives on or before February 8, 2019. Upon submission of the report, the study committee is abolished. The study committee must be staffed by personnel

as provided and assigned by the President Pro Tempore of the Senate, Speaker of the House of Representatives, and the Governor.

Department of Administration. The department indicates that this bill will have no expenditure impact on the agency since the study committee members will not receive compensation and are not entitled to receive mileage, per diem, or subsistence. Therefore, there will be no expenditure impact on the General Fund, Federal Funds, or Other Funds for the department.

House of Representatives and Senate. This bill creates a committee with two of the members being appointed by the Speaker of the House and two being appointed by the Speaker Pro Tempore of the Senate. The bill specifies the members of the committee are not entitled to compensation, including mileage, subsistence, or per diem. Therefore, this bill will have no expenditure impact on the General Fund, Other Funds, or Federal Funds for the legislative bodies.
