AGENCY'S DISCUSSION AND ANALYSIS

The University of South Carolina Sumter is an important, dynamic, regional campus serving a range of communities in the Midlands. Many are extremely impoverished small rural communities, while some are economically stable, small metropolitan communities. The University serves as a key institutional actor enabling future growth and prosperity in the region.

As a regional campus of the University of South Carolina, USC Sumter provides higher education and intellectual leadership for its service area in the counties of Clarendon, Lee, Kershaw, Sumter, and Williamsburg. To accomplish its mission USC Sumter employs a teaching faculty of high quality, dedicated to excellence in instruction, scholarship, public and professional service, and creative endeavors which enrich the classroom experience and community life. USC Sumter offers a varied curriculum grounded in the liberal arts and sciences focused on preparing students to continue their education in the University and throughout life. USC Sumter actively recruits students prepared to succeed in completing a baccalaureate-level education. While the institution is legislatively prohibited from offering remedial instruction, it is nonetheless able to admit most students who apply due to the close working relationship between students and faculty. The design of the institution incorporates a flexibility that allows changes in institutional capability to meet the ever increasing, and ever changing, educational demands of constituents.

The institution awards the Associate in Arts and Associate in Science degrees and provides for the completion of selected bachelor's degrees on campus through cooperative agreements and delivery structures with other USC System Campuses. USC Sumter also provides general education and upper division coursework applicable to baccalaureate degree programs offered by colleges and universities nationwide.

In addition to academic coursework, the mission of the campus includes non-credit courses, seminars, and workshops made available to the community through our Continuing Education program for cultural enrichment and professional development. The traditions of cultural diversity and freedom of thought are valued at USC Sumter. At USC Sumter a learning environment exists, that develops respect for racial, geographical, intellectual, and economic diversity, along with an awareness of individual, societal, and global responsibilities. USC Sumter promotes courses, activities, and attitudes able to influence the life of the mind in men and women and instill in them a thirst to continue learning throughout life.

USC Sumter emphasizes the development of the whole person and especially seeks to foster in students the knowledge and practices essential to an educated citizenry. Core competencies, including the ability to communicate through effective writing and articulate speech; computational and quantitative mastery; creative and critical thinking; and the duties of citizenship are strategically integrated within the curriculum. Classroom experiences, student activities, and physical education programs also provide opportunities for cultural enrichment, leadership development, intellectual growth, interpersonal relationships, and physical health, all contributing to a sense of self-reliance and a joy of learning.

USC Sumter was the first Regional Campus to offer fully online asynchronous classes, beginning in the first summer session of 2010. Since offering its first fully online courses, USC Sumter has continued to expand its offerings of online and hybrid courses to better enable opportunities and choices for its educational constituents. This growth includes increasing USC Sumter's active partnerships within USC Columbia's Palmetto College to offer more diversity in delivery methods and Baccalaureate degree opportunities, enabling educational opportunities for both its indigenous service area constituents and constituents of the University of South Carolina wherever they may reside.

On the USC Sumter Campus, the USC Aiken Business Program at Sumter offers an AACSB-accredited BSBA degree with the Management concentration from USC Aiken. After completing all their lower level degree requirements at USC Sumter, students who meet the admission requirements for the School of Business Administration (SOBA) Professional Program may enter the Aiken Business Program at Sumter. These students are then able to complete their upper level degree requirements through a combination of face-to-face classes taught by qualified SOBA faculty at USC Sumter and online classes taught by SOBA faculty from either Aiken or Sumter. These students are advised onsite by USC Sumter SOBA faculty. The Aiken Business Program at Sumter has been in existence for over twenty years enabling the recruitment and retention of students from the USC Sumter service area.

USC Sumter has greatly expanded its dual enrollment program for high school juniors and seniors, and created the first Early College (EC) program in the USC system. In the dual enrollment program, students can take 6 to 12 credits each semester while still attending high school. Dual enrollment students in the EC program, through careful planning and advising, can substantially complete all high school requirements by the end of their Sophomore year, and begin fulltime study at USC Sumter in the summer of their Junior year. At the end of their Senior year of high school, EC student can graduate with both a high school diploma and an Associate's degree from USC Sumter. Both programs are made possible through Lottery Tuition Assistance funding, which covers the cost of tuition, and students pay only for their textbooks. The EC program is a growing, successful collaboration between local high schools and USC Sumter that greatly lowers the cost of a college degree, decreases time to bachelor's degree completion, and demonstrates how inter-agency collaboration can create effective, efficient, and innovative programs that benefit South Carolinians.

Strategic Goals

The **Fiscal Year 2017-2018** Annual Strategic Goals of the University of South Carolina Sumter were directly tied to the University's Long Range Strategic Blueprint for Academic Excellence produced Spring 2017.

Goal 1 - Enrollment Management

As a Palmetto College Regional Campus. USC Sumter sought to supplement student needs, optimize financial and personnel resources, and improve enrollment and retention. Institutional effectiveness and efficiency in administration of academic and student support services helps ensure continued provision of Mission objectives related to higher education and intellectual leadership in USC Sumter's service area, along with helping stabilize and grow student enrollments.

Needs analyses performed by faculty, administration, and professional consultants, undertaken over the past two academic years prompted the development of a new enrollment management position. This is an executive level administrative position designed to better coordinate and integrate admissions and recruitment, financial aid services, and student success needs. A hire was made for the position. With the new hire we began restructuring enrollment management processes. This involved a restructuring of recruitment, admissions, and financial aid, along with developing new models of student recruitment, and student success strategies and tactics. Additional staffing, and a reorganization of several staffing areas were, and continue to be, undertaken to support this position and associated objectives.

The development of the enrollment management position, and subsequent reorganization of staffing, also freed up ongoing staffing constraints that were inhibiting adequate focus on other mission critical functions outside enrollment management.

Goal 2 - Alignment with Palmetto College Curricular and Advisement Needs

As a Palmetto College Regional Campus, USC Sumter sought to appropriately prioritize Palmetto College curricular and advisement needs in faculty hiring, faculty course offerings, and the training of faculty advisors. To replace losses due to attrition, critical tenure track hires were secured in disciplinary areas intended to make immediate contributions to critical curriculum need areas for both USC Sumter and Palmetto College programs. Efforts were made to increase the number of faculty participating in distributive education course offerings, professional development training programs, and new distributive education course development. Efforts were also made to more fully integrate our faculty advisement with Palmetto College advisement processes and the new Palmetto College Advisors Community of Practice.

Plans were developed to restructure the Palmetto College Coordinator position to be better situated to improve delivery of our local Palmetto Programs administrative processes, and to promote a greater prioritization of local marketing and branding of the Palmetto College mission, including enhanced support of both locally administered Baccalaureate programs and an increasing number of online Baccalaureate program opportunities channeled through the four-year system campuses. Near the end of the last annual cycle a hire was made to fill this newly restructured Palmetto College Coordinator position.

Goal 3 – Planning

As a Palmetto College Regional Campus USC Sumter sought participate actively in the Palmetto College 5th year Planning effort.

During the annual cycle USC Sumter began formal planning coordination with the Palmetto College Administration to identify possible strengths, weaknesses, opportunities, and threats (both internally and externally) to our mission. This work continues with a focus on developing short and long-term strategies and tactics to address issues facing Palmetto College.

The <u>Fiscal Year 2018-2019</u> Annual Strategic Goals of the University of South Carolina Sumter are directly tied to the University's Long Range Strategic Blueprint for Academic Excellence produced Spring 2018.

Goal 1 - Recruitment and Enrollment

As a Palmetto College Regional Campus, USC Sumter seeks to effect mission objectives through the maximization of sustainable enrollment patterns and the enhancement of quality student populations. Sustainable enrollments based on quality student populations are critical to meeting USC Sumter Mission objectives.

A newly created enrollment management position is enabling the optimization of staffing duties in recruitment and admissions services, and in financial aid services. These efforts are ongoing. They will optimize resources for more effective off-site recruitment; along with more effective communication strategies, and follow up tactics with admits, applicants with incomplete applications, and potential applicants with whom contact has been made. These restructuring efforts will also optimize the processing of applications and application decisions, and the awarding of financial aid and scholarships. This new position, in conjunction with advertising and marketing staffing, is also enabling more effective integration of advertising and marketing resources with recruitment and enrollment objectives. New data capacities now allow us to better access critical data on applicants and potential applicants. These data are being used to not only increase applications and admit yields, but to also develop improved branding strategies and tactics that optimize the marketing of the nature and value of the University's services. These new capacities allow more effective outreach to potential applicant

pools outside of the service area while still providing for the mission of USC Sumter to provide excellence in higher education and intellectual leadership in its service area.

Goal 2 - Retention, Success and Completion

As a Palmetto College Regional Campus, USC Sumter seeks to effect mission objectives by maximizing rates of student retention, Associate degree completion, and success toward Baccalaureate completion. Providing students with access to quality faculty and curriculum, along with institutional commitment to quality academic and administrative support services, are critical factors in meeting mission objectives associated with rates of student retention, student success and degree completion.

For enhanced retention efforts, we are engaged in proactive campus-wide advisement and registration campaigns introduced as a part of the strategic enrollment management plan over the last annual cycle. Communication via email, phone, and SMS text serve as follow-up techniques to communicate next-term enrollment opportunities to existing students. Early advisement and registration for students is being incentivized by providing early registrants with unique and engaging student life opportunities. We will continue to build upon past successes with ongoing innovation associated with faculty mentoring initiatives, tutoring services, and early intervention practices; and we are actively pursuing institution-wide long-range planning efforts to increase the efficacy of these academic support services.

Goal 3 - Faculty and Curriculum

As a Palmetto College Regional Campus, USC Sumter seeks to provide students with a quality faculty capable of providing the variety of curriculum offerings and educational delivery modes needed to effect mission objectives. A quality faculty capable of providing the variety of curriculum offerings and educational delivery modes needed to effect mission objectives directly aligns with the larger mission of Palmetto College. USC Sumter continues to make critical tenure track hires in disciplinary areas that make immediate contributions to critical curriculum need areas both at USC Sumter and for Palmetto Programs.

We also continue to promote faculty development of needed distributive education courses; expansion of faculty participating in distributive education course offerings: and professional development training programs. In addition, we continue to more fully integrate our faculty advisement with Palmetto College advisement processes and the new Palmetto College Advisors Community of Practice.

Goal 4 – Service and Community Engagement

As a Palmetto College Regional Campus, USC Sumter seeks to achieve mission objectives by continually strengthening current relationships, and by building new relationships, with community partners and stakeholders.

The traditions of cultural diversity and freedom of thought are valued at USC Sumter. We seek to provide a learning environment that develops respect for racial, geographical, intellectual, and economic diversity; and an awareness of individual, societal, and global responsibilities. Mission objectives cannot be effectively fulfilled without the input, resources, and expertise of a wide range of stakeholders and community partners within the institution's service area.

This year USC Sumter will reestablish a campus presence for the USC Sumter Alumni Council which has been in abeyance for several years. Council members serve as University Ambassadors at both institutional and

community events, organize Alumni events, facilitate Alumni fundraising, and in general help establish and maintain strong stakeholder networks within the Universities service area communities. The Council will begin meeting on a more regular basis now that the institutional commitment necessary to assist in their objectives has been secured. A new newsletter to help encourage participation and new membership in the Alumni Association is being developed as are plans for a more significant involvement in Commencement by members of the Alumni Association.

After several years of full-time staffing deficiencies in Alumni Relations, a full-time hire was made in University Development and Alumni Relations. Given the length of time that this administrative function was lacking appropriate staffing, action plan objectives over this next year will necessitate needs analysis and strategic planning aimed at restructuring the Office. This will enable optimization of the knowledge, enthusiasm, and resources our alumni provide for all University stakeholders.

The campus Dean also maintains community outreach as one of his primary goals. He is a member of a variety of community leadership organizations, economic development initiatives, and service organizations. He assures proper sponsorship of and staff involvement in community events, and encourages faculty and staff involvement in a broad array of community activities.

Goal 5 – Long Range Strategic Planning

As a Palmetto College Regional Campus, USC Sumter seeks to utilize institution wide planning processes to ensure improvement of the institutional effectiveness of its academic programs, academic support programs and administrative support services. Institution-wide Long Range Planning processes are integral to the sustainability and continual improvement of the University's capacity to meet mission objectives. This goal includes alignment of USC Sumter internal planning efforts with Palmetto College planning processes to better achieve mission objectives of both USC Sumter and Palmetto College.

USC Sumter reorganized its Long-Range Planning Committee in the Spring of 2018 to facilitate institution-wide planning aimed at assessing and improving academic programs, academic support services, and administrative support services.

The first charge of the newly reorganized Long Range Planning Committee is to gather and utilize empirical data on student engagement and student satisfaction to establish goals, objectives, and actions plans aimed at improving academic and administrative support services. This initiative involves participation, as one of approximately 1,200 institutional members, with the Center for Community College Student Engagement out of the University of Texas, Austin; and administering, for the second time in the past three academic cycles, the Center's Community College Survey of Student Engagement (CCSSE). Data from these comprehensive surveys will give us invaluable insight into the strengths and weaknesses of our academic and administrative support services, leading to more data informed decision-making processes in long range strategic planning. These data will be analyzed this upcoming year for insights into planning for the continual improvement of academic and administrative support services.

The newly formulated Palmetto College Coordinator position will provide more direct working contact and planning opportunities with Palmetto College central offices and the Senior System campuses hosting Palmetto College degrees. Establishing new networks and relationships associated with this position, to better facilitate alignment with Palmetto College in general, but also with Palmetto planning processes, will be critical for the upcoming annual cycle.

The new executive level enrollment management position will also begin to be integrated into an active role on the well-established Palmetto College Implementation team and a new Palmetto College Long Range planning committee.

Risk Assessment and Mitigation Strategies


Increasing enrollment at USC Sumter continues to be a primary focus. The tuition differential between us and CCTC next door, as well as an unfortunate growing overlap in mission, is a monumental hurdle for recruiting students. We have grave concerns that the SC Technical College system is positioning itself to deliver bachelors degrees in the near future, marking the greatest over-reach and confusion of mission yet attempted by this major competitor. Many of the students we serve are first generation students who have little experience or understanding of the white-collar job market. Further, they see the promises from CCTC of free tuition, lower admissions standards, and promises of a high paying technical job at a local plant as a better "deal" than a four-year time commitment, paying higher tuition, to get a job they don't have much personal experience with or understanding of (e.g., middle-management, professional services, etc.). If CCTC begins to offer bachelors degrees, the differentiation between the two institutions will likely be completely lost on the students we serve.

Recruiting students in this climate of competition is difficult, but several things would help. We need to add campus housing to attract a talented student body from across the state to come here, see the careers that are available in Sumter, and to recognize that Sumter is quickly becoming a destination of choice for major employers. Additional tuition mitigation would help us compete with CCTC—we need to be able to offer the same free-tuition programs as CCTC does. Finally, improved facilities to provide state-of-the-art educational experiences would greatly help recruiting and educational efforts.

University of South Carolina Sumter has placed the recruitment of additional students as one of its top priorities during this past Academic Year. In light of the retirement of the Associate Dean for Student Affairs, the campus undertook a study regarding structure and duties. It was determined that a new and more directed focus was needed on the functions of Enrollment Management. These duties had fallen under the Associate Dean for Student Affairs but were one set of many duties. As a result, the decision was made not to replace the Associate Dean but rather to redistribute the duties of that office and ire an Executive Director for Enrollment Management Services. This person began this position on April 24, 2017.

Financial Aid, Admissions, and Veterans affairs were brought together under the new Executive Director. With the thought of better integrating these crucial services aimed at moving students more efficiently, effectively, and quickly from inquiry to admitted status. A new CRM system has been instituted and is aggressively used to track and communicate with students. In Fall 2017 we experienced record enrollment growth, and preliminary Fall 2018 enrollments are trending similar to last year.

The Campus has also hired a new Palmetto College Coordinator and a Community Outreach Coordinator. This new Coordinator has aggressively exposed local organizations and businesses, as well as individuals in the community, to the growing range of Palmetto College 4 year degree programs. Preliminary Fall 2018 results show that his efforts are resulting in substantive increases in enrollments in these programs. USC Sumter continues to promote its first-in-USC Early College program in Sumter high schools and has grown from a beginning cohort of 13 students in Summer 2015 to a cohort of 41 beginning Summer 2018. Similarly, USC Sumter has developed exceptionally positive working relationships with Lexington and Richland School Districts and expanded dual enrollment programs with these schools. We are now exploring adding an Early College program in each of these districts.
