Key Points

- SC's demographics and economics are changing the next decades will not look like the past
- SC is currently one of the fastest growing states
- However, this level of growth is not consistent throughout the state; there is a wide disparity among counties
- Another impact of the changing dynamics is that finding workers will be more challenging
- This challenge will likely be amplified in some counties
- Growth affects the state and local economic base differently




1970 POPULATION PYRAMID




South Carolina had the 10th Largest Population Increase in the US Population increased by 91,001 (1.7%) from 2023 to 2024






South Carolina's Projected Population Change, 2020 - 2030 Wide range of experiences among the counties is expected



The declining percentage of workforce age population means there will be a relatively smaller pool, 208,000 people or 6%, to support the total population than in 2000





WORKFORCE AGE POPULATION COMPARISON, 2000 & 2030 Increase Needed to Maintain Ratio of Workforce to Population

SC Project Workforce Age (18 – 64) Population, 2020 – 2030 Again, wide range of experiences is expected among the counties









Unemployed Persons per Job Opening Both SC and the US are experiencing more job openings than unemployed people




UNEMPLOYED PERSONS PER JOB OPENING

South Carolina has a larger proportion of employment in manufacturing and leisure & hospitality and a lower percentage in health services




EMPLOYMENT BY SECTOR – 2024 AVERAGE

SC Employment Growth over the Past 10 Years Many sectors have seen employment growth of 20 percent or more





TOTAL EMPLOYMENT GROWTH BY COUNTY, 2014 TO 2024




South Carolina Per Capita Personal Income Despite faster growth, SC per capita income hovers around 82% of US average; Not necessarily bad given cost-of-living differences

South Carolina Personal Income Growth The proportion of income from earnings (wages, salaries, proprietor's income) has fallen since 1970; aging population increases transfer payments




SHARES OF SOUTH CAROLINA PERSONAL INCOME


Wages Account for 45.6% of SC Personal Income Wide range of experience by county

SOUTH CAROLINA ANNUAL PAY BY INDUSTRY, 2023






State and Local Tax Base



SC General Fund Revenue by Category 89% of General Fund revenue is tied to personal income (sales and income taxes)


FY 2023-24 GENERAL FUND REVENUE Percentage Distribution By Revenue Type (\$ Millions)





Local Government Revenue by Source Local government is mostly supported by local tax revenue


SOURCES OF LOCAL GOVERNMENT REVENUE FY 2022-23




Local Government Revenue from Local Sources Statewide, 39% of local revenue is from property tax, 29% from local sales taxes, and 32% license and other fees






Commercial Property Values

Commercial real property is the largest component of the tax base statewide at 35.8% of total property value, but percentage varies by county

COMMERCIAL & RENTAL PROPERTY VALUE as a Percentage of Total County Assessed Value - Tax Year 2022






Owner-occupied Property Values

Residential property is the second largest category at 35.4% of total value, but again, there is a wide range by county

as a Percentage of Total County Assessed Value - Tax Year 2022





Manufacturing Property Values Statewide manufacturing property is 3.2% of total property value; wide range again seen in counties
