Please accept my apology to staff of the Commission for the Blind and the people the Commission serves for cancelling today's meeting to provide public comment to the Healthcare Subcommittee of the House Legislative Oversight Committee. I would appreciate it if Commission staff would express that apology to the consumers and partners that committed to speak today. Pursuant to House Rule 4.4, no committee shall sit while the House is in session, without obtaining special permission from the Speaker. Because of the May 1st crossover deadline, it became necessary for the House to remain in session later than anticipated on Tuesday, April 26th; it was also imperative that members of the Healthcare Subcommittee remain in the chamber to participate in debate.
