

SOUTH CAROLINA COMMISSION ON HIGHER EDUCATION
COMMITTEE ON ACADEMIC AFFAIRS AND LICENSING
Committee Charter

1. AUTHORITY

As granted by the South Carolina Commission on Higher Education ("Commission"), pursuant to South Carolina Code ("Code") Section 59-103-25.

2. PURPOSE

To provide leadership and guidance to the Commission in pursuit of the statutory goals of high academic quality and instructional excellence, all in furtherance of the mission of higher education in South Carolina, as stated and delineated in Code Section 59-103-15 and more specifically defined in Code Section 59-103-30(A).

3. MEMBERSHIP

As determined by the Commission Chair and Executive Committee.

4. MEETINGS

At an appointed time, date and place, prior to each regularly scheduled meeting of the Commission, as recommended by Commission staff, approved by the Committee and Commission **and publicized in accordance with Code Section 30-4-80.**

5. RESPONSIBILITIES

(a) Primary review and recommendations of all applications for new majors, programs, schools, colleges and centers from research institutions, doctoral/professional universities, four-year colleges and universities, two-year institutions-branches of the University of South Carolina **and baccalaureate programs sought by technical colleges**, as referenced in Code Section 59-103-15.

(b) Primary review and recommendations of interstate reciprocity agreements that concern distance education, pursuant to Code Section 59-103-17.

(c) Primary review and recommendations of transferability of courses between two-year **(including technical colleges)** and four-year institutions, pursuant to Code Section 59-103-45(1).

(d) Primary review and recommendations of undergraduate admissions standards, pursuant to Code Section 59-103-45(2) and (3).

(e) Primary review and recommendations of developing mechanisms for gauging institutional academic success (**including enrollments, retention rates and graduation rates**) and of the promulgation of regulations to implement them, pursuant to Code Section 59-103-45(4)(a).

(f) Primary review and recommendations of any and all institutional mission statements, pursuant to Code Section 59-103-45(6).

(g) Primary review and recommendations of applications for licensure of nonpublic educational institutions (**including non-degree granting entities**), as defined and set forth in Chapter 58 of Title 59 of the Code.


(h) Primary review and recommendations for the accreditation and chartering of chiropractic colleges, pursuant to Code Section 59-103-120.

(i) Primary review and recommendations of REACH Act compliance, pursuant to Code Section 59-29-130.


(j) Other reviews and recommendations as referred or assigned by the Commission or by the Commission Chair.

Committee on Access & Equity and Student Services
Charter

Part I

1. Authority

As granted by the South Carolina Commission on Higher Education (“Commission”), pursuant to South Carolina Code (“Code”) Section 59-103-25 and in compliance with the Commission’s Bylaws (SC CHE Bylaws, Rules & Procedures, Section III.2).

The Committee may elect to revise this charter. However, any revisions to the final charter approved by the Committee and the Commission must adhere to the Commission’s Bylaws.

Purpose

The purpose of the Committee on Access & Equity and Student Services is to review, revise and approve policies and procedures for the administration of state scholarships, grants and programs assigned to the Office of Student Affairs and address statewide issues related to accessibility, affordability, and awareness of postsecondary education on behalf of SC students, service members, and families in compliance with Code Section 59-103-15(b), and attached Code of laws and regulations (Part II).

Responsibilities

- A. Review in advance and approve recommendations for submission to the Commission, relating to promulgation of regulations, proposed revisions to regulation, and operations that govern the state’s scholarship and grant programs to include Palmetto Fellows Scholarship, Legislative Incentives for Future Excellence (LIFE) Scholarship, SC HOPE Scholarship, SC Need-based Grant Programs (including College Transition Need-based Grant Program), Lottery Tuition Assistance, SC National Guard College Assistance Program, residency for the determination for tuition and fees, SC Program for the Recruitment and Retention of Minority Teachers, and administration of the SC Institutes of Innovation and Information. Code section/regulation governing these programs are place under Part II of this Charter.

- B. Monitor, review and approve reports, updates and activities that address accessibility, affordability, and awareness of postsecondary education on behalf of SC students, families, service members, school counselors and districts, to include financial aid awareness and FAFSA completion, postsecondary education preparedness, transfer of military credit to academic credit, college application assistance, and other programs/activities that support and promote access to postsecondary education.
- C. Review in advance and approve the proposed budget for the succeeding year for the SC Program for the Recruitment and Retention of Minority Teachers for submission to the Commission, Education Oversight Committee and General Assembly, and will review in advance and approve the proposed administrative budget for the SC Institutes of Innovation and Information.
- D. Review in advance and approve proposed revisions to policies and procedures for state scholarship appeals in compliance with state statutes and regulations.
- E. Review in advance and approve proposed revisions to residency regulations for determination of tuition and fees.
- F. Review, research, provide reports, and approve any other matter as assigned or under the purview of the Committee on Access & Equity and Student Services.

Membership

The Committee on Access & Equity and Student Services is defined as a standing committee per the Commission's Bylaws and made up of Commission members as appointed by the Chair of the Commission and Executive Committee. Members may be reappointed by the Chair of the Commission. The Chair of the Commission shall initially appoint the chair of this committee and thereafter, the Committee on Access & Equity and Student Services will elect its own Committee Chair and Vice-Chair (SC CHE Bylaws, Rules & Procedures, Section III.2.).

Meetings

The Committee on Access & Equity and Student Services will meet at an appointed time, date, and place, prior to each regularly scheduled meeting of the Commission, as recommended by Commission staff and approved by the Committee. The Chair of the Committee has discretionary authority to call a committee meeting. All meetings will be publicly announced and held in compliance with Code Section 30-4-10 - Freedom of Information Act.

Minutes

Minutes should include major topics of discussion, decisions, and action items and submitted for approval by the Committee at the next scheduled Committee on Access and Equity and Student Services meeting. The announcement of the committee meetings, minutes, and agenda will be publicly distributed through the Commission’s website.

Charter Approval, Review and Evaluation

The charter of the Committee on Access & Equity and Student Services will be reviewed and updated on an annual basis upon the election or reelection of the Chair of the Committee.

The charter shall be approved by a full committee vote during a convened meeting and posted on the Commission on Higher Education’s website.

5. RESPONSIBILITIES

(a) Primary review and recommendations of all permanent improvement project submissions, as defined under Code Section 2-47-50, from all public institutions of higher learning, as referenced in Code Section 2-47-40.

(b) Primary review and recommendations of the Comprehensive Permanent Improvement Plan submissions from all public institutions of higher learning, as referenced in Code Section 2-47-55.

(c) Primary review and recommendations of acquisition of real property, as referenced in Code Section 59-103-110.

(d) Primary review and recommendations of statewide fiscal-related policies, dashboards, or other fiscal matters related to public institutions of higher learning, as referenced in Code Section 59-103-20(b).



1. AUTHORITY

As granted by the South Carolina Commission on Higher Education ("Commission"), pursuant to South Carolina Code ("Code") Section 59-103-25.

2. PURPOSE

To provide leadership and guidance to the Commission in pursuit of the statutory higher education mission and goals as delineated in Code Section 59-103-15 (A)(1) and (A)(2)(d)(e)(f)(g).

3. MEMBERSHIP

As determined by the Commission Chair and Executive Committee.

4. MEETINGS

At an appointed time, date and place, prior to each regularly scheduled meeting of the Commission, as recommended by Commission staff and approved by the Committee and Commission.

5. RESPONSIBILITIES

(a) Develop counsel and strategy around the Commission's efforts to achieve a statewide postsecondary attainment goal;

(b) Provide comprehensive perspectives of the Commission's efforts to achieve a statewide postsecondary attainment goal;

(b) Guide the Commission's development of policy priorities, in close coordination with the Commission's state budget priorities;

(c) Counsel and make recommendations regarding the Commission's stakeholder engagement strategies and activities;


(d) Facilitate Committee member discussion about current topics or issues affecting higher education students, institutions, or South Carolinians; and

(e) Other reviews and recommendations as referred or assigned by the Commission or by the Commission Chair.
