Tuesday, June 26, 2024 Upon Adjournment of the House Blatt Room 433

I. The Economic Development, Transportation, and Natural Resources Subcommittee meeting was called to order by Chair Travis A. Moore on Tuesday, June 26, 2024, in Room 433 of the Blatt Building. Three subcommittee members (Chair Moore; Representative Russell L. Ott; Representative Gary S. Brewer, Jr.) were present for all or a portion of the meeting. Representative William M. Hixon and Representative Marvin R. Pendarvis were absent.

Minutes

Discussion of the South Carolina Forestry Commission

- I. Prior to beginning his testimony, Chair Moore reminds the Forestry Protection Chief Darryl Jones and Deputy State Forester Tom Patton that they were sworn in previously, and that they remain under oath. Chair Moore asks if there are any additional agency representatives who may address the subcommittee today or at future meetings that have not been placed under oath.
- II. Forestry Protection Chief Darryl Jones begins his presentation on forest protection to the subcommittee and discusses the following topics:
 - 1. Responding to wildfires;
 - 2. Preventing wildfires;
 - 3. Burning notifications;
 - 4. Enforcing forest law;
 - Educating the public about prescribed burning;
 - 6. Responding to disasters;
 - 7. Administering federal property and assistance programs; and
 - 8. Successes and challenges of the Forestry Protection Division.

Throughout his presentation, members ask Forestry Protection Chief Darryl Jones questions and he responds.

- III. Deputy State Forester Tom Patton begins his presentation to the subcommittee and discusses the following topics:
 - 1. Regional operations;
 - Regional salary, fringe, and operating expenses;
 - 3. Wildfire operations;
 - 4. Assistant regional foresters;
 - Unit foresters;
 - 6. Sector fire management officers;
 - 7. Frontline firefighters and tractor plow operators;
 - 8. Wildland fire occurrence and fire response allocation;
 - 9. Project foresters;
 - 10. Facilities management; and
 - 11. Challenges facing regional operations.

Throughout his presentation, members ask Deputy State Forester Tom Patton questions and he responds.
