The application for GS charges is handled by the Public Defender office. The PD office accepts the application and requires supporting documents (see attachment) and then forward the application to the bond court judge who decides if the person qualifies for appointed counsel or not. PD office visits jail daily to complete applications and forward them to the bond judge. Approved applications are returned to the PD office. The magistrate court handles the application, screening and approval for magistrate charges. They refer the approved clients to the PD office.

Magistrate interviews people while in jail. Then transmit paperwork to COC. If they qualify, the person then come to COC to pay \$40. COC does not follow up with info on Affidavit. If the person waives PD when Magistrate interviews and later wants PD, they are required to come to COC office and complete affidavit and pay \$40. The COC or Deputy COC will interview person. Verification of questionable information is sometimes required but not all the time. Just depends on if the interview raises concerns.

PUBLIC DEFENDER APPLICATION PROCEDURE

FAIRFIELD COUNTY

The COC office does all of the screening in the county for General Sessions, Summary and Municipal Courts. The defendant comes in and is given the Affidavit/Application for PD (Form approved by Court Admin). The defendant completes the form and the clerk that is working the desk then compare the reported income to the poverty guidelines table and approve or deny the application. They take the people at their word that the info is correct and do not verify. The information about property and debts is not considered nor verified. If the person list real property but his income is at or under guidelines, the application is approved.

PUBLIC DEFENDER APPLICATION PROCEDURE

FLORENCE COUNTY

Magistrate screens GS charges in bond court. The Application is used and compared to the Guidelines. If the person does not qualify or is missed during the bond hearing but wants to be reviewed later, he has to go to the COC to complete the application. The Public Defender screens Magistrate charges. The PD office requires the person to provide proof of their income or a notarized statement from the person supporting them.

PUBLIC DEFENDER APPLICATION PROCEDURE

GEORGETOWN COUNTY

Walk in clients come directly to the Georgetown Public Defender Office and complete the application. No documents required to verify income or assets. The income is compared to the Poverty Guidelines. If they are clearly over the guidelines, the Paralegal informs them that they are ineligible for a Public Defender. If they are eligible, the Paralegal requires that they pay with a Postal Money Order or Bank Money Order. The Money Orders are sent to the Horry County Public Defender Office quarterly and a single check to the State.

For Jail Clients: Every two weeks we review the Georgetown jail list to see if any General Sessions clients are there. Because they were unable to make their bond we assume they need our services. We open a file for them after checking the Georgetown Clerk of Court website to determine if they have retained an attorney.

GREENVILLE COUNTY

The County set up an Indigent Defense office that consist of 3 full time employees. This office handles ALL screening for the County. The office is an independent office. The office requires applicants to bring in documentation such as pay stubs, monthly bills, proof of spouse income, statement from employer, lease, etc. One of the staff persons review the application, documentation and ask applicant questions as needed. If approved, they send case to PD or Contract Attorney. Person denied may ask court to review the application.

The Magistrates screen defendants at the detention center. The Magistrates often determine if a defendant is over the guidelines. The PD office reviews the jail inmate list and if a person remains in jail for more than 10 days, a file is opened if the Horry County Website does not reflect that they have retained an attorney. Some people will apply directly at the Horry County Clerk of Court Office. All of these applications are scanned into the COC database. All fees in Horry County are paid to the Horry County Clerk of Court.

All GS and domestic violence Magistrate cases are screened by the Magistrate at the bond hearing. The defendant completes the affidavit prior to appearing before the judge for bond usually with one of the jailers. The judge scrutinizes the application and may inquire about specific information and determines if the person qualifies. If the app is approved it is forwarded to the COC with the warrants, etc for appointment of PD. COC puts info in file and forwards app and order of appointment to PD. Magistrate and Municipal cases are not screened at bond hearing. When person comes to court, the judge advises of right to counsel and if person wants atty they are instructed on how to go to COC to apply and their hearing is continued to give them opportunity to go to COC. These cases and some GS cases that were refused or waived at bond hearing are considered "walk in" applications. COC completes application based on what person tells them. COC reviews app and compare it to Poverty Guidelines to determine if qualify. Approved apps are forwarded to PD. No verification of the information just gut following and questioning of information as needed.

Magistrate Judge Todd is willing to serve on a committee to work on issue.

LANCASTER COUNTY

The Public Defender screens people that are in jail like once a week. Everyone that is out of jail must go to the COC office to apply for PD. COC accepts applications for magistrate, municipal and general session charges. When person comes to apply, the COC swears the person and then ask the questions on the PDA (public defender application). COC completes the application based upon information the person provides. They do not verify the information nor requires any documentation. “Most people reports that they don’t have a job in order to show a pay stub.” The income info is compared to the Poverty Guidelines. If person qualify, the app is sent to the PD or to the Magistrate or Municipal Court. That concludes the screening.

The COC does all of the screening for General Sessions and Magistrate Court charges. If the person is out on bond, they must go to the COC office to complete the Application for PD and pay the \$40 fee. The COC compare the information provided to the Poverty Guidelines and determine if they qualify. If so, the Order of Appointment is sent to the PD office. The COC does not require any additional documentation and take the person's word that the information is true. Sometimes the PD will check on tax records on some people and ask to be relieved if they have property in their names. If the person is in jail, they either call the COC office or writing the COC asking for an attorney. The COC sends an Order of Appointment to the PD and the PD visits the person and gets the application completed.

Magistrate screens for all cases. Judge completes Affidavit form with each person and compare it to the Poverty Guidelines. The Affidavit is then sent to the Clerk of Court office with the warrants. They avg about 3-4 people per bond hearing. Bond hearings are held twice a day (9 am and 3 pm). If the application is approved the COC fax it to the Public Defender. If at a later date the person who did not get a public defender decided he wants a PD, the person must go to the COC office. COC verifies if the information on the previous application is the same or changed. If changed, the person completes a new application and pay the \$40. The application is then faxed to the public defender office to make a decision.
