### **Public Service Commission Application Packet Instructions**

---

Thank you for your interest in seeking the office of Commissioner for the South Carolina Public Service Commission. **The State Regulation of Public Utilities Review Committee (“Review Committee”) will begin accepting applications on Monday, March 10, 2025. All application materials must be received no later than 12:00 noon on Friday, March 28, 2025.**

Below are details regarding the Review Committee’s application packet submission procedure, required application materials, and candidate resource documents. Please carefully review this information.

### **Application Packet Submission Procedure**

All required application materials must be submitted to the Review Committee in hard copy and electronic form unless otherwise indicated. The Review Committee will not accept application materials after 12:00 noon on Friday, March 28, 2025. This is an absolute deadline.

- (1) Electronic Submissions.** Completed application materials must be submitted electronically by 12:00 noon on Friday, March 28, 2025. Electronic versions of application materials do not need to be signed. Electronic submissions will be conducted using a secure file sharing application. Please contact Breeden John for instructions on electronic submissions once you have completed the application packet.

- (2) **Hard Copy Submissions.** The Review Committee must also receive signed original hard copies of completed application materials by 12:00 noon on Friday, March 28, 2025. Do not staple hard copies. All hard copies should include your original signature where indicated. If you are unable to mail hard copies of your application materials and need to submit them in-person, please contact Breeden John to make an appointment.

### **Required Application Materials**

(1) **Personal Information Sheet**

This document can be submitted separately from other required application materials and should be returned as soon as possible. Your name as provided will appear on media releases, screening reports, and other official documents. Certain information provided will be used to conduct a background check by the South Carolina Law Enforcement Division, a driver's record check by the South Carolina Department of Motor Vehicles, and a credit check by a credit bureau.

(2) **Personal Data Questionnaire**

The information you submit (with the exception of home addresses and telephone numbers, identifying numbers, names and ages of children, and other information where indicated) will be published by the General Assembly after public hearings. Specific instructions for completing the Personal Data Questionnaire are included in the resource documents. Please carefully follow these instructions.

(3) **State Ethics Commission Statement of Economic Interests**

Applicants are required to submit three copies of this form. All three copies must have your original signature. This form may be filled out by hand. The Review Committee will file these forms with House and Senate Ethics Committees prior to elections. Only signed hard copies of these documents are required, not electronic versions.

(4) **Confidential Financial Statement**

Instructions for completing this document are included with the document. Only a signed hard copy of this completed document is required, not an electronic version.

In addition to completing and submitting the required application materials (above), all applicants should review the following resource documents.

Standards for ethical conduct of members of South Carolina's judicial system.
- (9) **Advisory Opinion – Legislative Caucus Meetings**  
Review Committee Advisory Opinion addressing the issue of attendance by candidates for the Public Service Commission at legislative caucus meetings.
- (10) **Advisory Opinion – Legislative Receptions**
