SUBJECT: DEPARTMENT OF EMPLOYMENT AND WORKFORCE UPDATE

The South Carolina Department of Employment and Workforce has seen an unprecedented level of unemployment claim activity since the beginning of the pandemic. To date, the agency has been able to keep more than \$3.7 billion flowing to eligible South Carolinians through five unemployment benefit programs.

The historically high benefit payments for state unemployment insurance have had a significant impact on the agency's trust fund.

The above balance does not yet include the \$500 million CARES Act funding distribution appropriated by the General Assembly. This external funding will reduce the future unemployment tax burden on the state's businesses. Through August 1<sup>st</sup>, the agency believes that a minimum of \$599.9 million is claimable for CARES Act funding. This is likely to continue to grow as claim levels remain higher than their Great Recession peaks. Below is the agency's conservative estimate on unanticipated costs that are currently claimable for CARES Act funding as of August 1st.

The \$599.9 million estimate will continued to grow through the end of 2020. Using the agency's current trust fund projections, the ultimate claimable amount from the CARES Act could range from \$764.5 million to \$1,126.6 million depending on specific economic conditions that come to pass through the end of December.

As you are probably aware, the President took four executive actions this past weekend, one of which is a proposal concerning enhanced unemployment insurance benefits. As of the drafting of this correspondence, we still have a number of questions about how this could be implemented and are awaiting guidance from federal agencies.
