1	PROCEEDING 9:13 a.m.
2	CHAIRMAN SENATOR PEELER, JR.: Let's go
3	ahead and get started. Some members are having other
4	meetings and couldn't come along.
5	This is the Joint Legislative Committee to
6	Screen Candidates for College and University Boards of
7	Trustees. I'll call the meeting to order.
8	First up is Wil Lou Gray Opportunity
9	School. Angela Hanyak?
10	MS. HANYAK: Yes, Hanyak.
11	CHAIRMAN SENATOR PEELER, JR.: Hanyak, from
12	North Charleston.
13	Make sure your speaker is on and burning
14	green.
15	MS. HANYAK: Good morning.
16	SENATOR SCOTT: Good morning.
17	MS. HANYAK: Can y'all hear me?
18	MS. CASTO: Yes.
19	CHAIRMAN SENATOR PEELER, JR.: I can.
20	Let me swear you in first.
21	MS. HANYAK: Absolutely.
22	CHAIRMAN SENATOR PEELER, JR.: Do you swear
23	to tell the truth, the whole truth, and nothing but the
24	truth, so help you God?
25	MS. HANYAK: I do.

1	CHAIRMAN SENATOR PEELER, JR.: Would you	
2	like to make a brief statement on why you'd like to	
3	serve?	
4	MS. HANYAK: Absolutely.	
5	I have a passion for helping at-risk	
6	adolescents. In the Charleston area, I have been a	
7	mentor with an organization called Be a Mentor, and I'm	
8	seeking this board seat in the hopes of making a more	
9	systematic impact on the at-risk adolescent population	
10	in the state of South Carolina.	
11	CHAIRMAN SENATOR PEELER, JR.: Good. Thank	
12	you.	
13	Members, you have the information in front	
14	of you. Any questions or comments?	
15	REPRESENTATIVE WHITMIRE: How much do you	
16	know about Wil Lou Gray?	
17	MS. HANYAK: I know a good bit about both	
18	the founder and the school. I visited the campus on	
19	January 22nd this year. I was very graciously shown	
20	around by Director Smith. He gave me a wonderful sort	
21	of history, a recent history of the school. He told me	
22	a little bit about the profile of a typical student, the	
23	challenges that the school may face, and the successes	
24	that the school has faced.	
25	So I do believe that I have a good	

understanding of the school, its mission, and what needs
 to be happening for the school in the future for it to
 be successful.

4 REPRESENTATIVE WHITMIRE: Well, I've never
5 visited Wil Lou Gray. I need to, but I've heard nothing
6 but good things about the students. And the young men
7 and women who visit with us, I'm just highly impressed.
8 So somebody's doing a great job. So I hope that you
9 will, you know, continue that.

10 MS. HANYAK: Yes. I think it's quite an 11 impressive school for the state to boast, and I'm really 12 excited about the opportunity to contribute in any way 13 to it.

14 REPRESENTATIVE WHITMIRE: Great. 15 Speaking for Ms. Henderson and Ms. McLeod, 16 who are not here, we're glad to have some diversity 17 coming on the board. So thank you. MS. HANYAK: Wonderful. Thank you. 18 CHAIRMAN SENATOR PEELER, JR.: Mr. Scott? 19 20 SENATOR SCOTT: (Shaking head.) 21 CHAIRMAN SENATOR PEELER, JR.: Thank you. 22 Any other questions or comments? 23 REPRESENTATIVE WHITMIRE: Move for 24 favorable. 25 SENATOR SCOTT: Favorable report.

1 CHAIRMAN SENATOR PEELER, JR.: All in 2 favor, say aye. 3 ALL MEMBERS: Aye. 4 CHAIRMAN SENATOR PEELER, JR.: Opposed, no; 5 and the ayes have it. 6 Good luck to you. 7 MS. HANYAK: Thank you. 8 CHAIRMAN SENATOR PEELER, JR.: Next, 9 Reginald J. Thomas from Spartanburg, at-large seat. 10 MR. THOMAS: Good morning. 11 CHAIRMAN SENATOR PEELER, JR.: Good 12 morning. 13 SENATOR SCOTT: Good morning, Mr. Thomas. 14 CHAIRMAN SENATOR PEELER, JR.: Let me swear 15 you in. 16 Do you swear to tell the truth, the whole truth, and nothing but the truth, so help you God? 17 MR. THOMAS: I do. 18 CHAIRMAN SENATOR PEELER, JR.: Thank you. 19 20 Would you like to make a brief statement on why you'd 21 like to serve? 22 MR. THOMAS: Yes, sir. It's an honor for 23 me to even sit here and be considered to be a board 24 member for Wil Lou Gray Opportunity School because this is something that I've been doing all of my life. When 25

1 I read all about what Dr. Gray's legacy was all about, I 2 surely would like to continue her legacy. Looking at 3 what the school does and what she did runs parallel with 4 my DNA. 5 I'm one who will and has always been providing service to mankind, especially our youth, our 6 7 teens, our young adults. And I just think that my strength of what I do and can do can be offered, and I'm 8 9 honored to even be considered. 10 CHAIRMAN SENATOR PEELER, JR.: 11 Mr. Whitmire. 12 REPRESENTATIVE WHITMIRE: Welcome, sir. 13 I'm glad that you're willing to serve. 14 I'm reading here that you said that it's 30 15 percent in state versus out of state. How many 16 out-of-state students are served by Wil Lou Gray? 17 MR. THOMAS: I don't know. But in 18 answering that question, I did not know whether they had 19 out-of-state students or not. 20 REPRESENTATIVE WHITMIRE: I wouldn't think there would be. 21 22 MR. THOMAS: I know -- yeah. Most of our 23 institutions around the state have out-of-school --24 out-of-state students, but I wouldn't think that Wil Lou Gray Opportunity School would, knowing the kind of 25

1 students they take in from around the state. I was just 2 generally answering the question. I did not know it at 3 that time whether they did or not. 4 So had they taken any students, that would 5 have been my answer. REPRESENTATIVE WHITMIRE: I'd be interested 6 7 to know also. Maybe someone coming after you could 8 answer that. 9 MR. THOMAS: Since reading the information and following up on the history of the school, no, sir, 10 they don't. 11 12 REPRESENTATIVE WHITMIRE: Okay. Well, 13 thank you, sir. Good luck. 14 CHAIRMAN SENATOR PEELER, JR.: Mr. Scott, 15 do you have a question? 16 SENATOR SCOTT: No. CHAIRMAN SENATOR PEELER, JR.: What's the 17 18 desire of the Committee? REPRESENTATIVE WHITMIRE: Favorable. 19 20 SENATOR SCOTT: Favorable report. 21 CHAIRMAN SENATOR PEELER, JR.: Motion is a favorable report. 22 23 All in favor, say aye. 24 ALL MEMBERS: Aye. 25 CHAIRMAN SENATOR PEELER, JR.: Opposed, no;

1 and the ayes have it.

2 Thank you for your service, and I know 3 you'll do a great job. 4 MR. THOMAS: Have a blessed day. 5 CHAIRMAN SENATOR PEELER, JR.: Thank you. You too. 6 7 Doris McAdams, at-large seat. She's an 8 incumbent. 9 SENATOR SCOTT: Adams. It's Adams. CHAIRMAN SENATOR PEELER, JR.: How do you 10 11 do, ma'am? 12 MS. ADAMS: Good morning. CHAIRMAN SENATOR PEELER, JR.: Let me swear 13 14 you in. Raise your right hand. 15 Do you swear to tell the truth, the whole 16 truth, and nothing but the truth, so help you God? 17 MS. ADAMS: I do. 18 CHAIRMAN SENATOR PEELER, JR.: Thank you. 19 Would you like to make a brief statement? 20 MS. ADAMS: Well, I have served on the board -- this would be my third time, and I started 21 22 serving in 2008. We all know about Dr. Wil Lou Gray, 23 "Why stop learning?" I'm a former educator. I've 24 always worked with children, and it's always a pleasure 25 to see children that are at risk, having problems being

1 able to be successful and to find employment.

2 And this is what her mission was. When she 3 started out 95 years ago, she was interested in the undereducated adult. We're working with at-risk youth 4 5 between the ages of 16 and 19, and it is always a 6 pleasure to see them experience success again in the 7 workforce and be productive. 8 SENATOR SCOTT: Mr. Chairman --9 CHAIRMAN SENATOR PEELER, JR.: Ms. McAdams, your institutional motto is going to help us a lot. I 10 11 hear great things about Wil Lou Gray. Wil Lou Gray's 12 mission, is it similar to John de la Howe? What's the 13 difference between the mission of Wil Lou Gray and the 14 success of Wil Lou Gray that I hear is just the opposite 15 about John de la Howe, funding and so forth? Do you 16 know? 17 MS. ADAMS: You know, I think the stakeholders have a lot to do with success, whether one 18 19 has success and whether or not one does not have 20 success. When we have the right students with Wil Lou Gray and we have the right staff, that is very 21 important. When we have families that are supportive 22 23 and when we have a director and a board and, of course, 24 I cannot forget you legislators -- when we have you on our side, I think that's the reason there's a big 25

1 difference.

2	CHAIRMAN SENATOR PEELER, JR.: Thank you,
3	Ms. Adams. I called you Ms. McAdams.
4	MS. ADAMS: When you said McAdams, I said,
5	Where is she?
6	MS. CASTO: It's Doris M. Adams.
7	MS. ADAMS: Doris M. Adams.
8	MS. CASTO: I'm sorry.
9	CHAIRMAN SENATOR PEELER, JR.: Senator
10	Scott has a question.
11	SENATOR SCOTT: I can only say good things
12	about Ms. McBride Adams. Ms. McBride at the time I
13	first graduated from the college, she was one of my
14	earlier teachers in elementary school.
15	And so she's been an educator all of her
16	life, always an excellent teacher, professional, and no
17	nonsense. And I can say that she's a wonderful person
18	to be on that board.
19	And at the appropriate time, I would be
20	more than happy to move her forward.
21	CHAIRMAN SENATOR PEELER, JR.: I've been
22	wanting this moment for a long, long time. I have you
23	under oath about Senator Scott.
24	SENATOR SCOTT: And she has my permission
25	to be honest.

1	CHAIRMAN SENATOR PEELER, JR.: How many	
2	times did you send him to the principal?	
3	SENATOR SCOTT: They didn't do that at that	
4	time. That would be in class.	
5	MS. ADAMS: I'm sure that you all have	
6	heard that the students were a little different, and	
7	coming from homes where the parents put their foot down,	
8	that made a difference, and the encouragement that you	
9	had from the parents.	
10	And I see this a lot with some of the	
11	letters that our director receives from parents, and	
12	they are just elated. I mean, they are so happy when	
13	their children get on the right track and be productive,	
14	and that is our mission. That's our mission.	
15	CHAIRMAN SENATOR PEELER, JR.: Thank you.	
16	I can see now why you're such a good board member.	
17	Senator Scott moved for a favorable report.	
18	SENATOR SCOTT: Favorable report.	
19	CHAIRMAN SENATOR PEELER, JR.: Wait.	
20	Representative Whitmire.	
21	REPRESENTATIVE WHITMIRE: Thank you.	
22	A pleasure to meet you, Ms. Adams.	
23	MS. ADAMS: Thank you.	
24	REPRESENTATIVE WHITMIRE: I notice that you	
25	said that you're concerned about turnover of staff. Is	

1 it prevalent or just a small amount?

2 MS. ADAMS: No. You know, I felt like I 3 had to mention it because whenever we get information at 4 the board meetings, we look over the hires and the 5 resignations. And I noticed that in the human 6 specialist II area, it seemed like it was a large 7 turnover. Not a large turnover; maybe one or two each 8 time. 9 And I began to wonder. I said, Well, I 10 wonder what the problem is there. You know, maybe it's 11 salary, employment, problems at home. I just don't know, but --12 13 REPRESENTATIVE WHITMIRE: Is the staff on 14 the same pay scale as, say, public education or a different one? 15 16 MS. ADAMS: No, I'm not too sure about 17 that. 18 REPRESENTATIVE WHITMIRE: And I wonder if 19 that's --20 MS. ADAMS: If that is the reason? 21 REPRESENTATIVE WHITMIRE: Maybe it could 22 be, because I'm sure it's stressful in some ways. 23 MS. ADAMS: Yes, definitely. 24 REPRESENTATIVE WHITMIRE: Thank you. 25 CHAIRMAN SENATOR PEELER, JR.: Motion is a

1 favorable report on Doris M. Adams. 2 All in favor, say aye. 3 ALL MEMBERS: Aye. 4 CHAIRMAN SENATOR PEELER, JR.: Opposed, no; 5 and the ayes have it. 6 Thank you for your service. 7 MS. ADAMS: Thank you. And thank you for 8 aiding and helping the Wil Lou Gray School because we 9 really need the funding and everything, and we really 10 appreciate that. 11 REPRESENTATIVE WHITMIRE: Mr. Chairman, if 12 I may, you were mentioning de la Howe. You know, we 13 don't get to screen the de la Howe candidates. I'm wondering if that's -- if they came before us, maybe --14 15 but who knows. 16 MS. CASTO: Next. 17 CHAIRMAN SENATOR PEELER, JR.: Bryan B. England, at large. 18 19 MR. ENGLAND: Good morning. CHAIRMAN SENATOR PEELER, JR.: Good 20 21 morning, sir. 22 MR. ENGLAND: Good morning, sir. 23 CHAIRMAN SENATOR PEELER, JR.: Do you swear 24 to tell the truth, the whole truth, and nothing but the truth, so help you God? 25

1	MR. ENGLAND: I do.	
2	CHAIRMAN SENATOR PEELER, JR.: Would you	
3	like to make a brief statement?	
4	MR. ENGLAND: I would only say that it's	
5	been an honor to be on the board for the I guess	
6	about the past 12 years. I got on this board because I	
7	believe in what they do. I still believe in it, and I	
8	think it provides a great service to the citizens of	
9	this state. And I'm just honored to be a part of the	
10	board and to help it out in any way I can.	
11	Thank you.	
12	CHAIRMAN SENATOR PEELER, JR.: Questions or	
13	comments?	
14	Representative Whitmire.	
15	REPRESENTATIVE WHITMIRE: Good morning,	
16	sir.	
17	MR. ENGLAND: Good morning.	
18	REPRESENTATIVE WHITMIRE: I'm a former	
19	educator, so I can identify with Ms. Adams.	
20	That structured environment you mentioned,	
21	that's obviously the key. That's, unfortunately, why	
22	we're having so many problems, in my opinion, in public	
23	education today. We've just gotten way too many	
24	children who don't have parents or anyone. If they do	
25	have parents, they're not much of a parent.	

1	So that's why I think Wil Lou Gray is such
2	a godsend to some of these children. I know you're not
3	going to reach all of them, but, you know, if you reach
4	one, that's a success story.
5	So thank you for all four of you for
6	your willingness to serve.
7	(Ms. Henderson enters the room.)
8	CHAIRMAN SENATOR PEELER, JR.: Senator
9	Scott, any questions from you?
10	SENATOR SCOTT: Favorable report.
11	CHAIRMAN SENATOR PEELER, JR.:
12	Ms. Henderson, welcome.
13	REPRESENTATIVE HENDERSON: Thank you. I'm
14	sorry.
15	CHAIRMAN SENATOR PEELER, JR.: Any other
16	questions for Wil Lou Gray?
17	We're done.
18	Let me ask you, with your experience,
19	what's the common denominator of the student or child
20	that comes to Wil Lou Gray? What's the trigger and who
21	does the administrators of different school systems
22	or parents or
23	MR. ENGLAND: You know, I
24	CHAIRMAN SENATOR PEELER, JR.: how do
25	they know? How does my constituent know that there is a

1 Wil Lou Gray?

2 MR. ENGLAND: Well, we definitely increased 3 our advertisement and communication with the school 4 system and just to the general public. And, you know, 5 one thing I just -- this is a side answer, but I like 6 having my car sticker that says Wil Lou Gray, because 7 when they see it, you'd be surprised, you know, when people ask you a question. "Well, tell me about Wil Lou 8 9 Gray." My father knew about Wil Lou Gray because he was an old law enforcement guy way, way back, and he thought 10 11 the world of Wil Lou Gray, and he'd be happy that I'm on this board. 12 13 But, you know, coming up here this morning, 14 I heard something on the radio that said that -- you 15 asked about common denominators. Forty-one percent of 16 the children born in America today are born in a single-family environment. That's an awful lot. 17 18 REPRESENTATIVE WHITMIRE: And it's growing. 19 MR. ENGLAND: And it's growing. 20 And when I think about homes and stability in the homes and kids that I know, I kind of go back to 21 that; and not only with that, but the stability in that 22 23 home. Is there one of those parents on drugs, for instance, or do they have a criminal background? If you 24

1 know those kids, you know there's a lot of these kind of factors that enter into it. But I don't think there's 2 3 really one; I think there's a multitude of them. 4 REPRESENTATIVE WHITMIRE: One more 5 question. How many students do you serve? 6 MR. ENGLAND: We probably, on a quarter 7 system, are somewhere around 600 a year, something like 8 that. Pat could tell you exactly. 9 REPRESENTATIVE WHITMIRE: How long do they 10 stay? 11 MR. ENGLAND: They are on a quarter system, 12 about 14 weeks a guarter. I think that's right, 13 something like that. Now, they may stay longer than 14 that, and some will stay --15 SENATOR ALEXANDER: They finish the guarter 16 then go back --17 MR. ENGLAND: It depends on, I think, 18 whether they've gotten their GED and made the progress 19 that they need to make. And some of them, they're 20 allowed to come back to stay longer to get it. 21 REPRESENTATIVE WHITMIRE: As Chairman Peeler said, we're trying to wrap our hands around this 22 23 issue we have with de la Howe. And to be quite frank, 24 they aren't succeeding. And then we see your school, and it's a success. I wonder if we maybe can 25

incorporate some of your practices, you know.

2 MR. ENGLAND: Well, the structure, like I 3 told you, the disciplined environment --4 SENATOR ALEXANDER: The military -- yeah. 5 MR. ENGLAND: -- getting good quality administrators all throughout in those classrooms and 6 7 then a principal in the school, you've got to have 8 strong people there that are interfacing with these 9 kids. They are a special challenge, and it takes top-quality people. You can hire a few weak links, and 10 11 it can hurt you. 12 REPRESENTATIVE WHITMIRE: That's true. 13 As Chairman Peeler also said, how do you 14 hear about it? I've been an educator for 30 years, but 15 I'm 150 miles away. I haven't heard anything about it. 16 I've heard of the school, but I knew nothing about it. 17 So it seems to me that maybe we can outreach toward outer parts of the state a little 18 19 better, because it's such a wonderful opportunity. 20 We've got students with the same problems. 21 MR. ENGLAND: We do. Chairman Smith, now he publicizes a statewide map which shows where each one 22 23 of the kids are coming from, what county. It's always 24 interesting to look at, you know, where the kids are 25 coming from.

1 REPRESENTATIVE WHITMIRE: Who makes the 2 recommendation to send them? 3 MR. ENGLAND: Well, I think it can come 4 from a variety. They have to apply. They have an 5 application process, and they'll call the school, and 6 they'll go through an admissions process. 7 Now, they might be notified by -- someone 8 at the school about them. They might have a friend 9 that's told them about it. They can hear about Wil Lou Gray a lot of ways. 10 11 REPRESENTATIVE WHITMIRE: I just wondered 12 if they've gotten in trouble with the law or something 13 like that, and that was there instead of incarceration 14 possibly, you know --15 MR. ENGLAND: You know, I would --16 REPRESENTATIVE WHITMIRE: -- DJJ, they go 17 through Wil Lou Gray. 18 MR. ENGLAND: I don't know exactly, but I 19 do know -- I would think that we would have probably 20 stronger relationships with law enforcement, some counties that may recommend more than others and -- but 21 22 I think word of mouth. Nothing beats word of mouth, and 23 kids know if they've got a friend that went down there, 24 and all of a sudden they turned themselves around and is making progress and they tell somebody else. You can't 25

1 beat word of mouth.

2 REPRESENTATIVE WHITMIRE: Well, thank you. 3 Discipline and structure, that's the key, obviously. So 4 thank you. 5 MR. ENGLAND: Thank you. 6 CHAIRMAN SENATOR PEELER, JR.: Any other 7 questions? 8 Motion is a favorable report. 9 All in favor, say aye. 10 ALL MEMBERS: Aye. 11 CHAIRMAN SENATOR PEELER, JR.: Opposed, no; 12 and the ayes have it. Thank you, sir. 13 SENATOR SCOTT: Mr. Chairman. 14 CHAIRMAN SENATOR PEELER, JR.: Yes, Senator 15 Scott. 16 SENATOR SCOTT: And I know before we take a 17 break, I just wanted to add a little something to the 18 conversation, but I didn't want it to interfere with 19 getting these last questions. 20 There are about three to four mainstream 21 programs out there: Wil Lou Gray, Youth Challenge, and 22 the program we all have some concerns about over in 23 McCormick, and I don't know how the House is dealing 24 with and looking at the structure. Youth Challenge has been so successful for a long time because of military 25

1 relationships, but it's more military structured. I've
2 not had a chance to go and look at the other school
3 that's mentioned several times again to see in my
4 evaluating what may be the problem.

5 But you've got to remember these other two 6 programs are urban programs, and trying to design a 7 program and a rule of structure is a difficult program. 8 Even if we get Youth Challenge with Wil Lou Gray, Youth 9 Challenge has also been set on the Clemson University, 10 and Aiken had a little different twist to it.

11 And so we may need to look at the program 12 structure in what we ask the program to do and can the 13 school actually be given manuals and some other tools we 14 need to give the program, because at the end result of 15 it is can we move these children forward and get them a 16 GED, get them back in the mainstream. And I know that 17 we created alternative schools, and these schools are 18 dumping these kids either back in the street or they 19 don't make it, and some families are trying to give them 20 a tool by going to these different programs and trying saving these children. But, I mean, it's worth looking 21 at and really having some real conversation. 22

And if maybe restructuring the board might be an answer, I don't know, or just looking at what the actual program is. I think the House looks somewhat at

1 it, but it hasn't had a real -- a lot of

2 communication --

3 REPRESENTATIVE WHITMIRE: Right. 4 SENATOR SCOTT: -- from what I've gotten 5 from it. REPRESENTATIVE WHITMIRE: Well, Senator, I 6 7 believe de la Howe has been around since 1797, so it would be a real shame if we had to close it because 8 9 they're having problems. I can tell you that 10 Representative Bingham, who is over public education, 11 has mentioned Clemson taking it over. But I'm not sure 12 that would be the best. That's my opinion. 13 SENATOR SCOTT: But I don't think you fix 14 programs talking about programs. They can fix programs 15 with institutional knowledge and also looking at --16 REPRESENTATIVE WHITMIRE: Yes, and you're 17 right. It's in a rural area. 18 SENATOR SCOTT: -- educational programs to 19 tell you how you fix the --20 REPRESENTATIVE WHITMIRE: Way in a rural 21 area. 22 SENATOR SCOTT: No question. 23 REPRESENTATIVE WHITMIRE: So they have 24 different challenges, that it's not military. SENATOR SCOTT: Right. 25

1	REPRESENTATIVE HENDERSON: So I'm sure the
2	discipline is not nearly as, you know, in place as it is
3	at Wil Lou Gray. I just don't want to see it close.
4	And that's my worry.
