Agency Overview

Statutory Duties


The Office of the Secretary of State is mandated by the South Carolina Code of Laws to serve as the state filing office for business corporations, nonprofit corporations, limited partnerships, limited liability partnerships, and limited liability companies, as well as for all Uniform Commercial Code Article 9 secured transaction filings. The Secretary of State also serves as the agent for service of process for corporations that do not have authority to transact business in South Carolina and serves as registered agent as otherwise provided by statute. In addition, the Secretary of State's Office examines, and files state trademarks, registers structured settlement purchase companies, maintains the state notary public database, and issues commissions for elected officials and those appointed by the Governor. The Secretary of State's Office is also responsible for issuing all statewide cable franchises and serves as the repository for several types of municipal filings. The office handles the incorporation of municipalities and special purpose districts, the annexations of land, and the escheatment of real property in South Carolina. Finally, the Secretary of State's Office regulates charitable organizations, professional fundraisers, nonprofit raffles, business opportunities and employment agencies.

The mission of the Secretary of State's Office is to provide innovative technology to enhance the transaction of business in the state, to serve the business community and members of the public with prompt and efficient customer service, to protect the charitable donors of South Carolina, and to fulfill all other statutory duties of the office.

Budget Request Summary

I. New FTE in the Division of Public Charities – Administrative Assistant \$66,606 (includes fringe)

- ➤ The Secretary of State's Office has the responsibility of enforcing the Solicitation of Charitable Funds Act.
- ➤ In FY2023-24, over 17,000 charitable organizations registered or filed annual applications for registration exemption with the Secretary of State's Division of Public Charities.
- ➤ Initial charity registrations increased by 8.7%, a 1.5% increase over the previous year.
- As a result of continued collection of fine revenue for violations of the Solicitation of Charitable Funds, the office remitted over \$810,000 in fine revenue to the General Fund.
- An Administrative Assistant FTE is needed for the Division of Public Charities in order to meet the challenges of this increase in volume, in fulfilling statutory requirements, and providing customer service to assist individuals and Charitable organizations filing with the agency.

II. Other Funds Authorization Increase - \$150,000

- ➤ The office is seeking an increase of \$150,000 in spending authority to be spread throughout the programs in the agency to include agency retention, recruitment, along with information technology projects.
 - Approximately \$120,000 of that increase would be dedicated to retaining employees.
 - This funding will support recruitment efforts in light of several impending retirements.
 - The remaining requested funding will be spent on information technology projects. The agency continues to expand its IT services for customers to provide up-to-date, secure, and convenient infrastructure and security.

III. Other Funds Retirement, Health, and Pay Allocation – \$55,223

- The requested funding would support all divisions of the agency which are staffed by employees whose compensation is supported by other funds. Therefore, all goals and strategies the office seeks to meet would be impacted by the fulfillment of this funding request.
- ➤ The Secretary of State's Office has 16 FTEs supported by other funds. This funding request would support the Pay Plan Allocation in FY24-25 (\$46,676), along with the increase to the employer portion of health insurance. (\$8,547).

Maintaining carryforward funds is crucial for the agency's financial stability. These funds are essential in the event the agency encounters unexpected expenses, a downturn in revenue, or potential budget cuts in the future. This ensures that essential programs continue without interruptions.

The agency utilizes carryforward funding to support projects with the Department of Administration. The Secretary of State's Office has continuously relied on carryforward funds to upgrade and improve the office environment for staff and customers. Necessary security and safety measures were implemented for all staff by securing access to the office and providing secure workspaces for employees. Currently, we have initiated a project with the Division of Facilities Management and Property Services to replace old, outdated ceiling tiles, air registers, and office lighting with energy-efficient LED lighting throughout the agency.

The Secretary of State's Office remitted to the State General Fund over \$13.4 million dollars in FY 24. In FY 24, the office received general fund appropriations of \$1,468,202 and other funds authorization of \$3,051,504, for a total budget of \$4,519,352. Starting in FY 25, the office received general fund appropriations of \$1,568,202, and other funds authorization of \$3,234,472, for a total agency budget of \$4,804,674.

Legal staff supports each division of the agency and works directly with the Secretary of State, Administration, Division Directors, and all staff. Legal staff also work closely with the IT Division in the development of new online filing capabilities and is an integral component of the success of the agency. Legal and Administrative staff work to ensure excellent customer service for the agency along with each of the divisions in the office.

Information Technology Division

The IT Division also supports the entire office 24/7. Our IT staff provides internal and external customer service. Our online projects, filing options, day-to-day operations and security would not be possible without our IT staff. Current projects include a new online trademark filing system and enhanced services for our charities filings.
