Agency Information

- The Department of Alcohol and Other Drug Abuse Services (DAODAS) manages federal and state
 resources that ensure a continuum of Prevention, Intervention, Treatment, and Recovery programs and
 services are available and accessible to South Carolinians.
- Compared with other states both regionally and nationally South Carolina is more dependent on short-term federal funding to support public substance use services. Our state spends less per capita on substance use disorders.
- Recurring state investments will elevate South Carolina closer to the U.S. average and South Atlantic Region average of financing for addiction services.






FY 2025 Budget Distribution





Federal Supplements: Fiscal Cliff


- Federal grant supplements added over \$42M to DAODAS' budget between FY 2021 and FY 2025.
- Ensured that public service provider organizations and programs maintained operations and retained staff.
 - Allowed stabilization of workforce in a competing field.
- Supported enhanced fee-for-service rate payment that matched DHHS' increase.
- Essential to ensuring public access to addiction services.
- Funds will be entirely depleted by the end of FY 2025, and service provider organizations will face budget cuts, resulting in reduced service access.

Deaths for the 12 months ending in April of each year







1. Formula Grants & Direct Treatment Services \$9,070,000 Recurring

Formula Grants \$5,400,000

- County alcohol and drug authorities
- Clinical service provider retention and organization operability
- Ensures public access

Fee-for-Service \$3,470,000

- Fee-for-service payment for clinical & medical addiction care
- Aligns with DHHS' increased Medicaid reimbursement rates
- Ensures safety-net care

Transportation \$200,000

- Reimbursement for transportation costs
- Critical in rural areas





2. Residential Treatment & Withdrawal Management Access \$3,845,000 Recurring

Residential **Treatment &** Withdrawal Management \$3,845,000

- Fully staffing safety-net inpatient units
- Ensures existing inpatient and withdrawal management services operate at full capacity
- 40 withdrawal management, 63 residential, and 16 transitional beds
- Guarantees bed accessibility for patients regardless of ability to pay





3. Sustaining Recovery Community Organizations & Peer Outreach \$2,000,000 Recurring

Recovery Community **Organizations** \$2,000,000

- Competitive 3-year subgrants
- Building sustainability of Recovery Community Organizations through longer-term funding
- Ensuring peer services and community outreach with hospitals, law enforcement, and schools





4. Prevention Services Enhancement \$1,275,000 Recurring

Prevention Specialists \$465,000

- Supports each county currently without dedicated full-time Prevention Specialists
- Nine additional Prevention Specialists total
- Ensures county-specific coalition building & community-based prevention strategies

Formula Grants \$810,000

- Enhancing formula-based grants to ALL counties for primary prevention service materials such as school-based curriculums, educational material for community events, infographic/data visualization, and workforce development
- Each county currently receives \$1,833 in State funds for primary prevention services.
