- (a) 1999-2006 Associate attorney at Stuckey, Fata & Segars, Bishopville SC Handled family court cases, bankruptcy, criminal defense, personal injury, workers compensation and probate matters. I drafted and filed pleadings tried cases, settled cases, participated in mediations and several trials.
- (b) 2006-Present Owner and Operator of Saverance Law Firm, LLC, Sole Propriotorship. Handled family court cases, criminal defense state and federal, personal injury, workers compensation, disability and probate matters. I am in charge of all book keeping both general and trust accounts. I started the business from scratch and manage it myself. I have two legal assistants. I draft and file pleadings, file briefs and memorandums, attend hearings, mediation and have tried numerous cases.
- (c) 1999-2002 and 2007-2009 Public Defender for Lee County. During this entire period I was still involved in private practice. Handled all types of cases in General Sessions including some that potentially carried life without parole. Negotiated pleas, attended preliminary hearings, motion hearings and tried several cases. During this time I also handled cases defending persons charged with crimes in Juevenile Court in Lee County.
- (d) 2002-2006 Assistant Solicitor for Lee County. During this entire time I was still involved in private practice. In charge of handling prosecution of cases in General Sessions and Juevenile Court. Met with victims and law enforcement, negotiated pleas, participated in preliminary hearings and motion hearings. I also received two jury trial convictions on murder cases I tried.
- (e) 2006-2007 In charge of Prosecuting CDV cases in Magistrate Court for Lee County Sheriff Department. Met with witnesses, victims and law enforcement, negotiated pleas and tried cases.
- (f) 2011-2012 Contract attorney for DSS for Lee County. Managed docket and cases, met with witnesses and case workers. Tried dozens of cases, including TPR(s). Drafted and filed pleading and orders.
- (g) 2009-Present I am actively on the CJA list for Federal Court criminal appointed cases for the Florence Division. I was certified in 2009 and began receiving my own cases that Spring. I attend scheduling hearings, motion hearings, arraignments, pleas and sentencing hearings. I routinely negotiate pleas and prepare for trial. I have also filed numerous sentencing memorandums and variance motions. I have handled several federal criminal cases in the Columbia District. I have handled Post Sentencing hearings involving 35(b) reduction requests and Supervised Release violation hearings.

 - (1.) City of Bishopville vs. Marion Brunson, Jr., Common Pleas court in Lee County, South Carolina case number #2021-CP-31-00129. This matter was referred to me as special referee for Lee County pursuant to an Order of Reference filed on October 26, 2021 with the Lee County Clerk of Court. I reviewed the pleadings, service papers, and several exhibits that were placed into evidence at the Hearing including delinquent tax notices, a final notice of sell, and a final tax sale of information along with several other documents. There were approximately 10 exhibits admitted into evidence in this matter. Plaintiff moved before the Court to issue an order pursuant to S.C. Code section 15-53-10 et seq. to declare the Plaintiff the fee simple owner of the property and that any interest possibly claimed by the defendant be extinguished. I issued an Order granting the relief requested by the Plaintiff.

- (2.) Southern Gaines, LLC vs. Charles D. Holland et al, 2022-CP-31-00200 Common Pleas court for Lee County, South Carolina. This matter was referred to me as special referee for Lee County, in which the Plaintiff was seeking an Order of foreclosure and other relief. Plaintiff was an LLC and the record owner of the real property involved in this matter. The Defendant was a purchaser of this property pursuant to a contract of sale and agreement. In 2018 the Defendant, Charles D. Holland died. Plaintiff instituted an Order of foreclosure seeking a foreclosure on the property, an Order finding the decedent Chales D. Holland and heirs in breach of the contract. The Plaintiff waived a deficiency judgement against the Defendants. I reviewed the pleadings in this matter, reviewed the transcript of testimony, was involved with the notice of sale pursuant to the special referee's foreclosure sale, issued an order of foreclosure and an order confirming ownership and report of sale and disbursements as to the real property.
- (3.) Gwen Hornsby vs. John Doe, et al 2021-CP-16-00642 This matter was referred to me on October 21, 2021. I reviewed pleadings including the Summons, Complaint, and Notice to Quiet Title, scheduled a Hearing, reviewed exhibits at the Hearing and received testimony. Plaintiff was seeking and Order to quiet title of real property described in the pleadings. Certain Defendants were named as John Doe and Richard Roe since they were unknown to the Plaintiff, I had to review the notices that were run by publication, and Lis Pendens.

I have also handled foreclosure cases in front of a Master-In-Equity representing Plaintiffs and at other times Defendants.

- 15. List five of the most significant litigated matters you have personally handled in either trial or appellate court, or before a state or federal agency. Give citations if the cases were reported and describe why these matters were significant.
 - (a) The State vs. Dorian J. Cain, 2004-GS-31-006, General Sessions Court in Lee County South Carolina. I was the prosecutor handling this case. I was solely responsible for preparing the case, preparing the indictment, handling motions, selecting a jury and trying the case. The Defendant, who was 18 years of age, was charged with armed robbery which occurred on or about December 18, 2003 of two elderly gentlemen at a barber shop in Bishopville, South Carolina. Based on testimony, 3 young males came in the building and two of them were carrying guns and demanded wallets from the victims. The Defendant was stopped in a vehicle later that day, was taken into custody, and was brought to the scene and identified by the victims. Defendant was indicted for two counts of armed robbery and plead not guilty and a jury trial began on April 6, 2004. Prior to trial, Defendant made a motion to suppress the in court identification of the Defendant alleging it was unnecessarily and unduly suggestive. The court denied the motion. The court also denied the Defendant's motion to dismiss for lack of probable cause to establish the stop and arrest. As stated above, I personally handled and argued

each of these motions. As prosecutor, I called several witnesses in my case in chief including the investigating officer, witnesses, and the victims. The Defendant was convicted on two counts of armed robbery as the jury returned the verdict on April 8, 2005, Defendant was sentenced to ten years. Post trial, someone in the community pressured one of the victims to execute a document which allegedly called his identification of the Defendant into question. This motion was heard on June 23, 2004 and handled by myself. At the Hearing, the victim disavowed the affidavit and reiterated his trial testimony and the motion was denied.

- (b) Tommy Collins, deceased, claimant vs. BellSouth Communications, Inc. Employer and BellSouth Telecommunications, Inc. Broadspire Carrier South Carolina Workers Comp Commission WCC File Number #0411606. I was the sole attorney handling this matter on behalf of the claimant's heirs/beneficiaries. The claimant was employed by BellSouth Telecommunications Inc. and on June 13, 2004 Mr. Collins along with another employee were sent to Richland County, South Carolina to perform work related duties. Mr. Collins and the other employee were encouraged by the employer to stay at the hotel off Hwy 76 in Richland County because they had another job the next morning which they were required to attend. Both employees traveled in a company vehicle to the hotel and were staying in rooms at the hotel near one another. On July 13, 2004 around 9:30PM Mr. Collins walked across the street directly in front of the hotel and was struck and killed by a vehicle. The accident occurred a short distance from the hotel in which the claimant was staying. The employer paid for the hotel accommodations and provided a meal allowance for the claimant. Also, the claimant was subject to being called after hours by his employer which would sometimes require him to perform another job after normal working hours. The claim was denied by the carrier alleging that the claimant's injuries did not arise out of the course and scope of his employment. This case involved issues related to "personal comfort doctrine" and the "slight deviation doctrine". After a contested trial the claim was denied. We appealed this matter and the case was settled prior to a decision on the appeal.
- (c) State of South Carolina vs. Chad James, Eunice Davis McCall, and Efrain Thomas 2005-GS-31-102 General Sessions Court in Lee County. I was the sole prosecutor handing this case. Enice Davis McCall and Efrain Thomas were prosecuted for the murder of Troy Rouse occurring on or about April 7, 2005 in violation of section 16-3-10 of the Code of Laws of South Carolina (1976), as amended. The victim had seven gunshot wounds combined from the front and back. He was shot with two different firearms, one firearm from Mr. McCall and another firearm from Mr. Thomas. One of the unique aspects in this case was that the state had to prove that the gunshots from two defendants and two different guns both contributed to the death of Mr. Rouse. I called approximately a dozen witnesses in my case in chief which included witnesses, a pathologist, law enforcement investigators, and witnesses from SLED. Mr. Thomas shot the victim multiple times in his back while Mr. McCall shot the victim in the chest area at close range. Among other documents admitted into evidence were pictures, copy of the SLED trace evidence report, copy of the SLED firearms report, ballistic reports and the autopsy of the victim. The

Defendant, Efrain Thomas was convicted by a jury of the murder of Troy Rouse and was sentenced to 30 years. Defendant Eunice Davis McCall was convicted of manslaughter and was sentenced to imprisonment.
