I have also represented debtors in defensive matters involving commercial and consumer foreclosures including a currently pending matter in Georgetown County. Within the past five (5) years, I have spent less time in the courtroom as the commercial transactional side of my practice increased. Prior to that, I was in the Master's Court 5 to 10 times per month depending on the caseload. I have also maintained a relatively consistent level of construction litigation since joining Callison Tighe & Robinson in October 2006.

I represented a transferee in a fraudulent transfer case brought by the United States under the Federal Debt Collection Procedures Act seeking to claw back a gift of Two Million Five Hundred Thousand and 00/100s (\$2,500,000.00) dollars. The Gift had been made by my client's old friend who was had been found liable for One Hundred Seventeen Million and 00/100s (\$117,000,000.00) dollars judgment under the False Claims Act. This presented many intricate issues related to insolvency and alleged fraudulent transfers as well involved an adversary action against my client by a liquidating trustee in United States Bankruptcy Court for Eastern District of Virginia. It was ultimately resolved through mediation.

 (b) In re: Ashley Oaks Development Corporation, Case No. 10-04801-jw, I represented two creditors in a Chapter 11 proceeding. I successfully obtained relief from the automatic stay based upon an access issue to the property and its effect on the value of the property which required expert witness testimony related the lack of access and valuation. I also was successful in having the matter dismissed in the face of opposition from the Debtor and the United States Trustee.
 - (c) Santander Bank, N.A. v. Saluda Motor Sales, Inc., et al., 2019-CP-41-00018, this was an action related to a floor plan financing agreement. A minority shareholder in Saluda Motor Sales, Inc. misappropriated funds and submitted false inventory requests and extended the floor plan financing credit line to cover his tracks. He further bilked thirdparties into investing in a business venture and shifted funds between the businesses. A receiver was appointed and appearances required in a federal criminal case to represent the client's interests related to restitution. There is related action filed against my client, among others, related certain payments to the Lender made under the floor plan financing agreement which is still pending while the parties complete the settlement terms. (d) South Carolina Electric and Gas Company v. Structural Preservation Systems, LLC, et al., Case No. 2017-CP-20-00117, I represented two creditors with mechanics liens and claims totaling in excess of Fifteen Million Eight Hundred Thousand and 00/100s (\$15,800,000.00) dollars. This was an extraordinarily complicated case that involved numerous creditors, the failure to post a bond by the general contractor as required under S.C. Code Ann. § 29-6-250, a guaranty from the general contractor's parent company that was liquidated by the Plaintiff, and bankruptcy issues in the Southern District of New York. Had the Chapter 11 plan filed by the general contractor not been successful, this litigation would have been extraordinarily complicated and resulted in rulings on many novel issues of law.
 - (e) <u>Summit National Investments IV LLC v. Medcare Express Management, LLC, et al.</u>, Case No. 2016-CP-10-02229, this was a case involving a struggling urgent care business throughout South Carolina. While litigation was commenced and motion for a receiver appointed, we were able to enter into settlement negotiations and restructure the debt without having to liquidate the assets. I have handled many kinds of cases in my career that start as litigation and are successfully negotiated to avoid a lender's remedy being enforced.
