My experience with criminal law started once I graduated from law school and started clerking for Judge Newman back in 2004. I have been handling criminal law matters for eighteen years now. Most of my criminal law experience has been as a prosecutor; however, in private practice I have had criminal defense clients with cases in Summary Court as well as in General Sessions. I also work with the Sixth Circuit Solicitor's Office prosecuting all kinds of criminal matters from domestic violence court, to juvenile court, to high level felonies. I've referenced a few cases in Number 15.

The issues involved in my criminal cases are all over the board. It could be a juvenile waived up to General Sessions, it could be issues related to the chain of custody for drugs, it could be a statement made by a child in a forensic interview setting. I've had all of these issues come up before and then some. I am in Circuit Court at least five days a month, usually more.

My civil practice consists mostly of post-conviction relief matters, a few personal injury matters, general civil litigation, as well some immigration cases. While most people probably don't think of post-conviction relief as a civil matter, these cases are civil and are filed in Common Pleas. Instead of a Summons & Complaint, the Applicant files an Application. Instead of an Answer, the State files a Return. Otherwise, all the same civil rules of procedure apply. I have been doing post-conviction relief matters since 2006. I continue to do them now via appointment or by being retained. I have probably handled close to 400 of these cases. Most of the issues involved in these cases related to ineffective assistance of counsel of their prior criminal attorney since these cases are collateral attacks on criminal convictions. I have also been handling quite a bit of litigation in probate court as well as some general civil litigation matters including breach of trust, breach of contract, etc.

In addition, my civil practice also consists of general civil matters in magistrate courts as well as appeals from magistrate court, some family court matters, probate, and civil cases in federal

court. Some of the types of cases I have handled/filed in magistrate courts include breach of contract type matters, restraining orders, etc. My family court experience has been with simple divorces, name changes, gender marker changes, as well as juvenile prosecution matters. In federal court I have filed federal habeas corpus cases and writs of mandamus related to immigration matters. I have also handled vital records litigation in Circuit Court.

    - a. The vast majority of my practice is in trial court. I would estimate at least 85% of what I do is in trial court. (I am including both jury trials and bench trials.) If I were to split between jury and non-jury practice, I would estimate that 20% of my criminal cases end up as a jury trial, while the remainder of my cases are bench trials or are matters that are generally handled short hearings. (i.e. Juvenile trials, post-conviction relief matters, and family court matters.)
  - (c) What number of cases went to trial and resulted in a verdict?
    - a. This is a hard number to quantify as I handle both jury and non-jury matters but over the past five years I estimate I have tried to verdict at least six jury trials. (This includes during the COVID shut down.)
  - (d) What number of cases went to trial and resolved after the plaintiff's or State's case? (Resolved may include settlement, plea, by Judge's order during a motion hearing, etc.
    - a. Again, difficult to quantify simply because record management does not distinguish between a matter that started as a trial and ended up with a guilty plea. I estimate I have had at least another five cases where a jury was pulled and/or opening statements or the State's case was presented and then the Defendant decided to plead guilty.

This course teaches the basics of how to do competent research online by analyzing the source, date of publication, the author, etc., while also teaching the differences between opinions (most blogs) to news and periodicals.

# (a) <u>Kasyjanski v. Fairfield County Solicitor's Office et. al.</u> 0:23-cv-01756-JFA

US District Court for the District of South Carolina. Mr. Kasyjanski had several pending criminal matters in Fairfield County. Some were related to threats made to the Solicitor's Office. (He has also threatened to kill every judge that has touched his criminal cases in any way.) The Attorney General then stepped in to prosecute. Mr. Kasyjanski has been found not competent and has been committed to SCDMH. At the time he filed this action he was in the detention center awaiting a bed at the Department of Mental Health. He filed the complaint on April 27, 2023, against myself and many other individuals associated with Fairfield County. The case was dismissed on June 23, 2023. I was never served with the Complaint.

# (b) <u>Tuner v. Donohue, et. al.</u> 7:17-cv-02425-DCC

While I was at the Attorney General's Office I prosecuted a case against Mr. Turner, the former mayor of the Town of Lyman. He was charged with violation of the state wiretap statute and misconduct in office. (He allegedly conspired to destroy evidence in a federal investigation and set up video recording through town hall to listen to everyone's conversations.) After I left the Attorney General's Office the case against Mr. Turner ended up being dismissed, as it turned out the main witness against him was also embezzling from the Town of Lyman.

This civil case was removed to the US District Court for the District of South Carolina on September 8, 2017, and I was timely served with the Complaint. (I was never actually served with the Complaint while it was filed with the Court of Common Pleas in Spartanburg County.) I was sued in my individual capacity for compensatory and punitive damages. A motion to dismiss the case against me was filed on October 6, 2017, requesting dismissal based on prosecutorial immunity. A Stipulation of Dismissal on my behalf was entered on November 13, 2017.

# (c) Pickett v. McMaster, et. al. 4:09-cv-01481-PMD

US District Court for the District of South Carolina. This was a federal habeas corpus matter filed on June 10, 2009. I was never served with the petition but was listed as a respondent in the matter because I was the Assistant Attorney General who had handled Mr. Pickett's post-conviction relief matter for the state in state court. This matter was summarily dismissed on February 22, 2010.

#### (d) <u>LaConey v. Lott, et. al.</u> 3:21-cy-02740-CMC

US District Court for the District of South Carolina. Mr. LaConey was a defendant in a harassment case I was handling just before I left the Attorney General's Office in 2016. Many Circuit Court judges were the victims of the underlying state criminal matter against Mr. LaConey. He filed this case on August 25, 2021, against numerous individuals including myself, the sheriff, and victims of his criminal matter attempting to sue under 18 U.S.C. §241 (a federal criminal statute). I was never served with the Complaint and this case was dismissed on March 31, 2022. I was dismissed as a defendant based on prosecutorial immunity. Mr. Laconey did try to appeal this to the 4<sup>th</sup> Circuit Court of Appeal. That appeal was dismissed on September 26, 2022. (0:2022cv.pr01479)

# (e) <u>Kasyjanski v. Allyene et. al.</u> 1:24-cv-02278-JFA

US District Court for the District of South Carolina. I discovered this case while researching the answer to this question. This is a new case filed by Mr. Kasyjanski. He has been found not competent, not likely to be restored and has been committed to SCMDH. I was never served with this complaint. It was filed on April 22, 2024. This case is still pending.
