1. Why do you want to serve as a Circuit Court judge?

Serving as a Circuit Court judge has been a dream I wanted to pursue since I was a prosecutor in the Fifth Judicial Circuit. Additionally, serving as a Circuit Court Judge aligns with my conviction to serve our state at the highest level my skill and ability allow.

2. Do you plan to serve your full term if elected?

Yes.

3. Do you have any plans to return to private practice one day?

4. Have you met the Constitutional requirements for this position regarding age, residence, and years of practice?

5. What is your philosophy regarding *ex parte* communications? Are there circumstances under which you could envision *ex parte* communications being tolerated?

Ex parte communications should be avoided to protect the integrity of the judiciary and the judicial process. Canon 3 of the South Carolina Judicial Code of Conduct provides exceptions for ex parte communication, but my goal would be to involve all parties in all communication with the court.

6. If you disclosed something that had the appearance of bias, but you believed it would not actually prejudice your impartiality, what deference would you give a party that requested your recusal? Would you grant such a motion?

I would give great deference to a party that requested my recusal if the party believed something I disclosed gave the appearance of bias. Upholding the judiciary's integrity, independence, and public confidence is vital to maintaining America's democracy. I would address recusal motions on a case-by-case basis to fully unpack the potential bias by seeking to understand the party's basis for the motion. I would more likely than not grant the recusal motion if the party articulates the appearance of bias, and I cannot clearly articulate how and why I can maintain my impartiality to the moving party's satisfaction.

7. How would you handle the appearance of impropriety because of the financial or social involvement of your spouse or a close relative?

I would confront the matter directly by requesting an ethics opinion from the South Carolina Bar Ethics Advisory Committee and the State Ethics Commission. Additionally, I would request that my spouse or close relative cease and desist the activity in question.

8. What standards would you set for yourself regarding the acceptance of gifts or social hospitality?

I would not accept gifts or social hospitality.

9. How would you handle a situation in which you became aware of misconduct or appearance of infirmity of a lawyer or of a fellow judge?

First, I would discuss that matter with the accused. Then, I would report the matter the appropriate authorities as required by the Judicial Code of Conduct.
