 I have held judicial office as Family Court Judge, First Judicial Circuit, Seat 1, July 2001-present, elected February 2001. The Family Court has exclusive jurisdiction over all matters involving domestic or family relationships. The unified statewide Family Court system was established by statute in 1976. Pursuant to this provision, the Family Court is the sole forum for the hearing of all cases concerning marriage, divorce, separate maintenance, custody, visitation rights, termination of parental rights, adoption, alimony, child support, division of marital assets and debts and change of name. South Carolina Family Court has exclusive jurisdiction over any actions concerning children living within its jurisdiction as outlined in SC Code Annotated Section 63-3-530. This includes exclusive jurisdiction over minors under the age of seventeen alleged to have violated state or municipal laws.

 - (a) Ryan Campbell Dennis v. Holly Camille Yates, issued on December 19, 2006, in Richland County Family Court, Case No. 2005-DR-40-4139, reversed as <u>Doe v. Roe</u>, 379 S.C. 291, 665 S.E.2d 182 (Ct. App. 2008), reversed as <u>Doe v. Roe</u>, 386 S.C. 624, 690 S.E.2d 573 (2010). This was a termination of parental rights case in which I ordered that Father's parental rights be terminated. The Court of Appeals reversed my decision, finding that termination of Father's parental rights was premature and was, therefore, not in the child's best interest. The Supreme Court reversed the Court of Appeals, affirming the Family Court decision that terminating Father's parental rights was in the best interest of the child.
 - (b) Melissa Leaphart Hagood v. James Buckner Hagood and Melody "Suzie" Hagood Sharpe, issued on July 5, 2016, in Richland County Family Court, Case No. 2014-DR-40-1541, affirmed as <u>Hagood v. Hagood and Sharpe</u>, 2018-UP-471 (Ct. App. 2018). This divorce case involved a substantial dispute over custody between biological parents and a third party relative. I found the biological parents unfit to parent and awarded custody to the third party relative. The Court of Appeals, in an unpublished opinion, affirmed the award of custody to a third party relative.
 - (c) Mitchell Goldman v. Jane Goldman, issued on April 16, 2018, in Dorchester County Family Court, Case No. 2016-DR-18-1859, affirmed as Goldman v. Goldman, 2021-UP-014 (Ct. App. 2021). This was a termination/reduction in alimony case where I ordered a reduction in Husband's alimony payments to Wife but did not terminate his alimony payments completely. The Court of Appeals affirmed my decision, in an unpublished opinion, regarding the award of attorney's fees to Wife, the denial of a retroactive alimony reduction to Husband, and the decision not to completely terminate or further reduce Husband's alimony obligation.
 - (d) State of South Carolina v. Kemondre Glover, issued on May 3, 2022, in Orangeburg County Family Court, Case No. 2021-JU-38-126, 127, 128, 129 & 130. This is a Final Order in which I waived jurisdiction of a juvenile to General Sessions Court after review of the factors established by Kent v. United States, 383 U.S. 541 (1966).

- The juvenile in this case fired a gun into a crowd of students as school was being released, severely injuring three students.
- (e) South Carolina Department of Social Services v. Donna Bolin and Maurice Evans, Order on Rule to Show Cause, issued on November 17, 2023, in Orangeburg County Family Court, Case No. 2023-DR-38-548. I issued this Order as a result of a <u>Sua Sponte</u> Rule to Show Cause issued against Orangeburg County Department of Social Services for failing to comply with an Order to conduct expedited paternity testing. The Orangeburg County Department of Social Services was found in contempt of court and ordered to pay a fine to the Orangeburg Clerk of Court, which fine could be suspended upon the filing of the paternity test results by a specified date.

The specific authority of the managers is delineated in fourteen subparagraphs of the Operating Agreement. The general responsibilities of the managers include managing seven tracts of land owned by the family limited partnership, including selling land, managing timber stands, negotiating hunting and pine straw harvesting leases and maintaining the tracts, farm equipment and pond house owned by the LLC. My term of service is until I die, resign or become incapacitated.

 - (b) I was a named party in a Federal civil lawsuit filed in the Fourth Circuit US District Court for South Carolina, along with Judge Nancy C. McLin, Judge William J. Wylie, Jr., and two attorneys in Dorchester County. The lawsuit was filed by Robert McDaniel Cox. The date of the suit was October 27, 2011. I was never served with Mr. Cox's lawsuit. The

suit was dismissed by Judge David Norton on December 28, 2011, for failure to prosecute. After becoming aware of this lawsuit, I reviewed Mr. Cox's Family Court file in Dorchester County. A review of the file revealed that I never presided over a hearing in Mr. Cox's case, and I never signed an Order related to his case.

- (c) I was a named party in a Federal civil lawsuit filed in US District Court for the District of South Carolina by William V. Jamison on May 24, 2011. I was never served with Mr. Jamison's lawsuit and was not aware of it until it was listed on my SLED report during my last screening in 2018. The suit was dismissed by Judge Margaret Seymour on July 15, 2011, for failure to prosecute. Mr. Jamison's complaint stemmed from his incarceration which occurred when he failed to purge a 90-day sentence by paying a specific amount toward his child support arrearage by a certain day. I issued the Civil Contempt Order, giving Mr. Jamison the ability to purge the 90-day sentence. When Mr. Jamison was seen in Family Court on the bench warrant issued due to his failure to comply with the Civil Contempt Order, his bench warrant was heard by another judge who issued a stiffer sentence and purge amount than I had ordered in the Civil Contempt Order. Mr. Jamison was complaining that I had not vacated the other Judge's Order regarding sentencing and purge amount. I do not have authority to change the terms of another Judge's Court Order.

Additionally, I am encouraged by the Family Court Bench's collaborative efforts to develop new approaches to our work. I am thankful for the opportunity to serve as a Family Court Judge, and I hope to continue this service to my community and state.
