**Question # 34 Supporting Documents:**

(c) Has a tax lien or other collection procedure ever been instituted against you by federal, state, or local authorities? If yes, please provide details.

The IRS and South Carolina Department of Revenue (SCDR) have both instituted collection proceedings against me in the past. I do not have any current liens, of which I am aware. Attached are prior liens and proof of satisfaction for each. I was unable to locate proof of satisfaction for two (2) liens (Law Office of Shannon D. Matthews—Tax-Lien # 3-51236774-8, \$840.00 (2009) & Shannon Matthews—Tax-Lien # 3-50812202-1, \$387.49 (2004)). Over the course of a week, I spoke with several different customer service representatives at SCDOR. All advised me that there was no record of any liens. Each indicated that the age of the liens was a factor in locating any information. I was directed to the Agency website, to search the “Lien Registry,” ([mydorway.dor.sc.gov/LienRegistry](http://mydorway.dor.sc.gov/LienRegistry)). The registry allows one to enter names and/or lien numbers. I searched the registry and there are no liens listed. Nevertheless, I also requested and paid for a Certificate of Compliance on November 12, 2024. I was advised that it takes seven (7) to ten (10) business days to research an account and provide the Certificate of Compliance. As of the submission of this amendment (November 15, 2024), I have not received the Certificate of Compliance.
