

Divorce: Almost 100% of my practice involves divorce. The few that do not usually are because a Decree of Separate Maintenance and Support is sought or the action involves a modification of alimony; support; custody or visitation. I have had a great deal of experience in all of the fault ground pleadings and proof required at trial. Now most cases settle in mediation so the necessity of having fault is not as useful as it may have been in the past.

Equitable division: Over the course of my practice I have worked on a plethora of equitable division matters ranging from multi-million dollar marital estates to a case involving only a family Bible and a quilt. During the years of the real estate recession, much of my practice in the coastal areas demanded division of negative equity, which is a challenge. I am well versed in the language of business valuations and have worked often with tax and valuation experts.

Child custody: My practice consists of the complex custodial matters which range from special needs physical challenges to severe psychological impairments of either a child or a parent. I have worked assisting military members who have suffered traumatic brain injuries or severe PTSD with finding ways to have meaningful relationships with their children. I have a

great deal of experience as a Guardian representing the best interests of minor children. I often work with expert psychologists and therapists in my cases.

Adoption: My practice has consisted of handling mostly step-parent adoptions and guardianships for school purposes. I will have to become more familiar with private and agency related adoption law.

Abuse and neglect, and juvenile justice: My only experience with abuse and neglect cases comes from being appointed to represent parents in DSS cases. I have only handled one or two juvenile cases over the years and those were very early in my practice. I have been studying the code for the juvenile requirements of the Bench and feel that I will be able to appropriately handle juvenile matters.

I appear in front of the Family Court Bench very frequently and have over the last 5 years. I do not try as many cases as I used to since I am most often able to resolve my cases in mediation. I have appeared most often lately pursuant to Rules regarding contempt, motions for temporary relief and procedural motions.

 - I was appointed to represent a young woman in a DSS case who had had her children taken from her for neglect. The neglect sprang from her leaving a home wherein she was being physically abused and the children were with a babysitter. My client ran because of an outstanding probation violation charge that she knew would put her in prison. She was arrested eventually. I was appointed while she was in prison. The children were placed with the paternal Aunt. Once my client got out of jail, she tried diligently to complete the safety plan and the requirements that DSS had set out for her. The problem was that the treatment plan was grossly beyond the scope of a finding of neglect. To

further compound the problem, DSS failed to make the necessary referrals. My client, with my guidance, completed all of the requirements on a private basis. The GAL never visited my client's home or met with her outside of monitoring a visitation. I filed a Motion for the Judicial Review hearing to be scheduled and was able to get a day certain. At the conclusion of the trial, the Court ordered the minor children returned to my client, that very day. I have never had that happen before and haven't again. I watched my client grow from being an insecure victim with mental health problems, and no real parenting or employment skills, to a confident, assertive, adult who was in charge of her own life and her own children. She went to work, secured housing and got her life back on track. I was very proud to have aided this young woman in putting her life back together with her children.

- Most of my cases involve assisting individuals in putting their lives back together after a very traumatic and emotional event. I take a great deal of personal pride in seeing my clients leave me ready to experience and cope with the new "normal" in their lives. While I wouldn't say my cases are insignificant, there are none really responsive to this question except as set out above.

My first job was at the age of 13, and I served breakfast and lunch at a little hotel on the Myrtle Beach Boardwalk called, "The Wee Blue Inn". This was the summer of the Watergate hearings. I worked at Cape Craft Pine which was a gift store in Myrtle Beach for one or two summers.

I worked in the food service industry every summer after that at various places until the late 1980's. I was either a bartender or a waitress. I worked as a waitress at an Italian restaurant in Myrtle Beach called Raimondo's. I worked as a waitress at Cagney's Old Place in Myrtle Beach, which is no longer open, in 1977 and 1978. I worked as a waitress at the East Bay Trading Company, which is no longer open, in 1978 and a few more years, in downtown Charleston. I worked as a bartender at Captain Cocktails in Mt. Pleasant, SC in the early to mid-1980s, which is no longer open. I worked at a little luncheon diner in Mt. Pleasant but I don't remember the name.

I worked both at Wild Dunes in the catering department and then worked for a private catering company called Caterer's Extraordinaire in Charleston. This would probably be from the mid 1980's until I left for paralegal school in 1989. Wild Dunes has changed hands several times since I was there and Caterer's Extraordinaire is no longer open.

I worked as a domestic and criminal trial paralegal for James W. Hancock, Jr., from 1990 until graduating from law school, in Rock Hill, South Carolina. Mr. Hancock died in 2015.

In my practice I handle the hiring and the payroll information; the application of the benefit programs in place for the staff; I monitor the collections and the accounts receivable on a weekly basis.  - I have practiced family law all over the state of South Carolina for 16 years. I love the Family Court and the practice of family law. I know the law. I know the rules of evidence and of civil procedure. I have seen the impact of the family court on families.

I believe I was arrested at some time right after college because of having a suspended license. I was not aware of the suspension and very quickly got it straightened out. I do not remember the year.

I do not believe I was a named litigant. It is possible that it was my insurance company. I attended but did not testify. This would have been in 1976 or earlier.

Right after college I worked for a catering company and when the company disbanded there was argument as to what was owed to me as commission. I had an attorney and negotiations were held. I do not believe any action was filed but I am not positive. This would have been in 1981 or 1982.
