S. 222 - Senator Ott: A BILL TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY ADDING SECTION 56-2-140 SO AS TO DEFINE THE TERM "UTILITY TERRAIN VEHICLE" AND PROVIDE FOR THE REGISTRATION AND OPERATION OF THEM ON THE HIGHWAYS AND STREETS OF THE STATE; BY AMENDING SECTION 56-1-10, RELATING TO DEFINITIONS, SO AS TO REVISE THE DEFINITION OF THE TERM "OFF-ROAD USE ONLY"; AND BY AMENDING SECTION 38-77-30, RELATING TO DEFINITIONS, SO AS TO REVISE THE DEFINITION OF THE TERM "INDIVIDUAL PRIVATE PASSENGER AUTOMOBILE" TO INCLUDE CERTAIN UTILITY TERRAIN VEHICLES.

S. 387 - Senator Kimbrell: A BILL TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY AMENDING SECTION 56-1-10, RELATING TO MOTOR VEHICLE DEFINITIONS, SO AS TO DEFINE A MEDIUM SPEED VEHICLE; BY ADDING SECTION 56-2-107 SO AS TO PROVIDE CONDITIONS FOR OPERATION OF MEDIUM SPEED VEHICLES; BY AMENDING SECTION 56-2-110, RELATING TO DRIVER'S LICENSES AND REGISTRATION CARDS, SO AS TO PROVIDE REQUIRED DOCUMENTS FOR A DRIVER OF A MEDIUM SPEED VEHICLE; BY AMENDING SECTION 56-2-120, RELATING TO TITLE REQUIREMENTS, SO AS TO PROVIDE REQUIREMENTS FOR THE TITLE OF A MEDIUM SPEED VEHICLE; AND BY AMENDING SECTION 56-2-130, RELATING TO DEALER LICENSING, SO AS TO MAKE CONFORMING CHANGES.

H. 3292 - Reps. Hixon, Pedalin, W. Newton, and others: A BILL TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY AMENDING SECTION 56-2-105, RELATING TO GOLF CART PERMITS AND THE OPERATION OF GOLF CARTS, SO AS TO PROVIDE CERTAIN MUNICIPALITIES AND COUNTIES MAY ENACT ORDINANCES TO ALLOW GOLF CARTS TO OPERATE IN DESIGNATED AREAS WITHIN THEIR JURISDICTIONS AT NIGHT.
